**Clearfield County, ss:**

At a Court of Quarter Sessions of the Peace of the county of Clearfield, held at Clearfield, in and for said county, on the 10<sup>th</sup> day of Jan'y A. D.

1881, before Judges of said Court, upon a petition of ~~John Wayne~~ sundry inhabitants of the Township of Sandy

in said county, setting forth that he is in want of a Private Road to lead from Public Road running from Carbois to west Liberty to the dwelling of the petitioner in said Twp.

and therefore praying the Court to appoint proper persons to view and lay out the same according to law, and make report to the Court whereupon the Court, upon due consideration had of the premises, do order and appoint A. J. McHugh John Blair & W. A. Brothers who, after being respectively sworn or affirmed to perform the duties of their appointment with impartiality and fidelity, are to view the grounds proposed for said road, and if they view the same and any two of the actual viewers agree that there is occasion for such road; they shall proceed to lay out the same agreeable to the desire of the petitioners, as may be, having respect to the best ground for a road and the shortest distance, and in such manner as to do least injury to private property, and state particularly whether they judge the same necessary for a public or private road, together with a plot or draft of the same, with the courses and distances and reference to the improvements through which it passes, and shall also procure releases of damages from persons through whose lands said road may pass, or failing to procure such releases, shall assess the same, if any sustained, and shall make report thereof to the next Court of Quarter Sessions to be held for the said county, in which report they shall state that they have been sworn and affirmed according to law. Notice is directed to be given to the owners or occupants of seated lands through which the within road is intended to pass, of the time of the view, according to the 147th rule of Court.

## RELEASE OF DAMAGES.

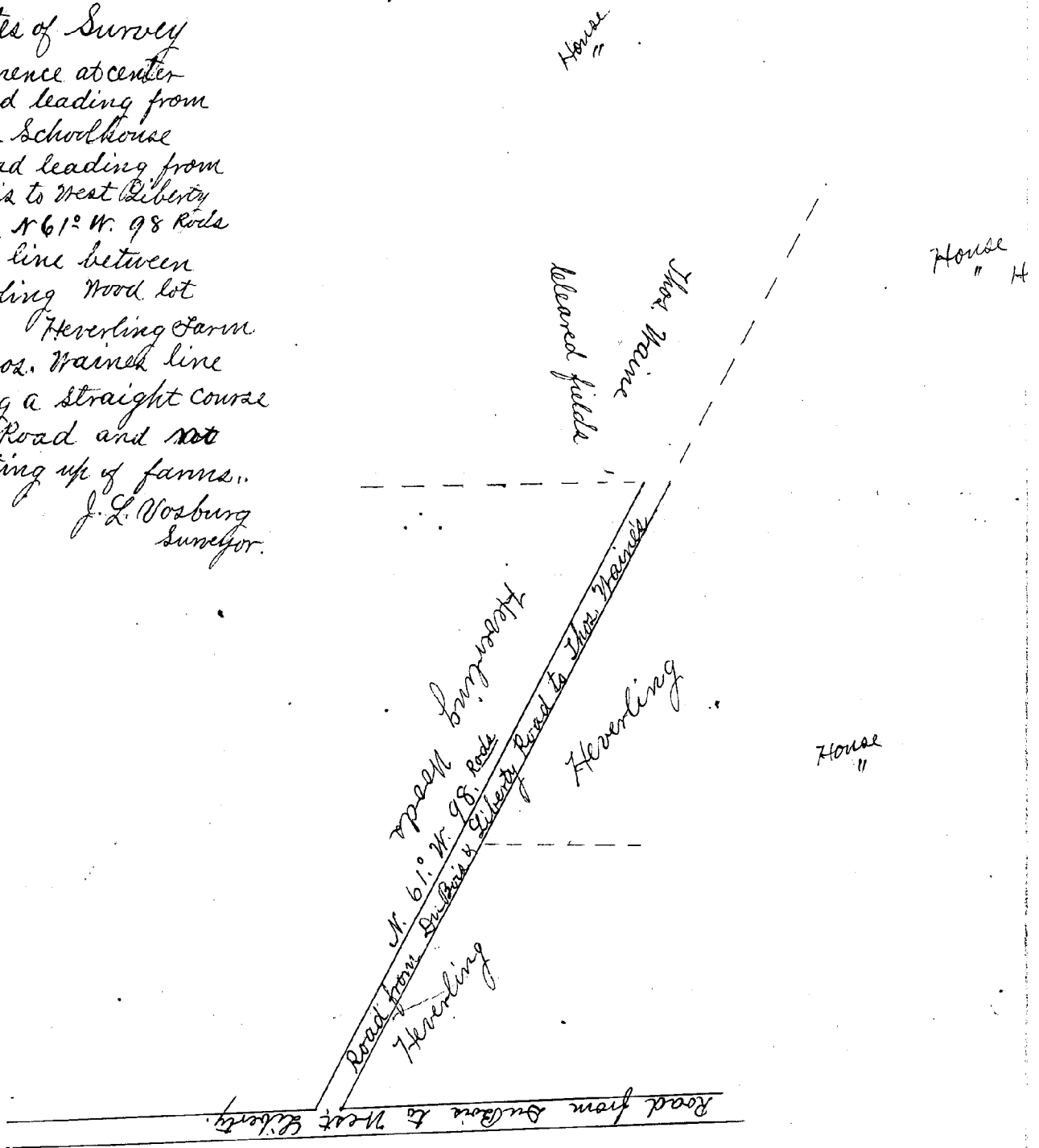
NOTE.—In case of a Private Road, the release must be executed in favor of the petitioner for said road.  
Also— Viewers will carefully note the number of days employed and set the amount out at the foot of their return.

Reviewers cannot interfere with damages assessed by the original viewers, except so far as the location may be changed by the reviewers.

N. B.—If the viewers believe the parties are not entitled to damages, taking into consideration the advantages as well as the disadvantages of the road, they will report to that effect.

To the Honorable the Judges of the Court of Quarter Sessions of Highland County,

We the undersigned persons appointed by the foregoing order of Court, to view and lay out the road therein mentioned respectfully report;

That having all been present, (notice having been previously given according to law of the time and place of holding said view,) on the 12<sup>th</sup> day of March at 9 o'clock A.M. 1881 to view of the ground proposed for such road and having all been sworn or affirmed in pursuance of the said order, we have viewed and laid out, and do return for Private road use the following road to wit; (but would recommend to the Court that said road be made a Township, as it will be needed for Township travel and accommodation) Beginning at Center of Road leading from White School House (from Dubois) to West Liberty, thence N. 61 degrees West Ninety eight Rods along line between Heberlings woods lot and Heberlings farm to Thomas Waynes line, being a straight course from road and no cutting up of farms, and further we assess no damages as no injury is done but rather that said road is an advantage to the land which it passes through.

Which said road as laid out, we are of opinion is necessary for a public or private road.
