

Sessions in the within or annexed order.

We, two of the persons appointed by the  
said Court to view and lay out the road therein  
mentioned do report that having first given no-  
tice according to law of the time and place of  
the view and having been duly affirmed  
in the Recumward form prescribed by the  
said order did view the ground for the proposed  
road and have laid out and now return the  
same for a public road. Beginning at a point on  
Public Road leading from Nashville to Giles Bridge  
a short distance east of Henry Heverly's in Beccaria  
Thence by line dividing lands of S. Heverly, H. Heverly  
South three degrees (S. 3° W.) West one thousand and  
nine and one half (109 $\frac{1}{2}$ ) perches to White oak, down  
Thence by dividing line of S. Heverly, and Joseph Troel  
lands South four degrees (S. 4° W.) West Ninety two  
(92) perches to post. Thence through lands of Joseph  
Troel South forty four degrees (S. 44° W.) West  
Fifty (50) perches to a point on County line near  
Joseph Troel to be immediately run shortly to be laid  
out in Lawrence County.

At a Court of Quarter Sessions of the Peace of the county of Clearfield, held at Clearfield, in and for said county, on the 29 day of Sept A. D. 1881, before Judges of said Court, upon a petition of sundry inhabitants of the Township of Beccaria in said county, setting forth that they labor under great inconvenience for want of a Public Road to lead from point on Public Road leading from Titusville to Gills Bridge at or near Henry Henrys to a point on County line near Joseph Isocells

and therefore praying the Court to appoint proper persons to view and lay out the same according to law, ~~Sett or Report to Court~~ whereupon the Court, upon due consideration had of the premises, do order and appoint Sam'l Haggerty Thos. A. Fleck & John H. Held who, after being respectively sworn or affirmed to perform the duties of their appointment with impartiality and fidelity, are to view the grounds proposed for said road, and if they view the same and any two of the actual viewers agree that there is occasion for such road, they shall proceed to lay out the same agreeable to the desire of the petitioners, as may be, having respect to the best ground for a road and the shortest distance, and in such manner as to do least injury to private property, and state particularly whether they judge the same necessary for a public or private road, together with a plot or draft of the same, with the courses and distances and reference to the improvements through which it passes, and shall also procure releases of damages from persons through whose lands said road may pass, or failing to procure such releases, shall assess the same, if any sustained, and shall make report thereof to the next Court of Quarter Sessions to be held for the said county, in which report they shall state that they have been sworn and affirmed according to law. Notice is directed to be given to the owners or occupants of seated lands through which the within road is intended to pass, of the time of the view, according to the 147th rule of Court.
