To the Honorable Court of Quarter Sessions of Clear-
fild County:-

The Petition of the undersigned, cit-
izens of Pike Township, Clearfild County, Pa.
respectfully represents:- That the Township of
Pike has recently been put to the expenditure
of a large sum of money for the erection of
a costly bridge at the Village of Bridgeport
in said Township in said County.

That the erection of this bridge was in pur-
suance of certain proceedings legally had in
your Court whereby an appropriation from
the County was recommended:

That owing to the extraordinary expenditures
necessarily made by the County in 1889, the
officials of Pike Township, asked for only
the sum of One thousand dollars at that time
under an arrangement with the County Com-
missioners by which they might present their
application at this time for an additional sum.

That the sum of one thousand dollars was
appropriated by the County and applied to
the erection of this bridge; the total cost of
erecting and fitting for travel of said bridge
