The petition of the
undersigned Citizens of Huston Town-
ship in Said County respectfully rep-
resents:-

That a Bridge over Bennett's
Branch of Unmanning Creek at the
place where the same crosses the public
road leading to Tyler Station on A & R R
is necessary - That its erection requires
more expense than is reasonable that
one Township should bear, and is more
than said Township ought to be ex-
pected to bear. That said Township is
building the abutments for said bridge
and the same are now approaching
completion:-

Commissioners of said County be author-
ized out of County funds to build the
superstructure of said Bridge, or furnish
said Township the funds necessary to
build it.

Your petitioners, citizens and property owners in Huston Township, in said County, hereby represent that a bridge is needed across the Bennetts Branch at Tyler to reach the R.R. station, the Coal and Coke works, and adjacent settlements. — — — — —

The Township is now building substantial stone abutments and hereby ask the County to put on the iron superstructure. The Township is in debt about \$8000. We have lately lost two important bridges by floods. We hardly feel able to build this bridge without assistance. And think we are justified in asking assistance from the County. The span is 65 feet between the face of the abutments, and the width 16 feet.
