we, The undersigned, viewers ap-
pointed by the within order of
Court to view the bridge therein
mentioned respectfully report:-
That we gave good and lawful
notice of said bridge view and
met agreeable thereto on Monday
The fourth day of September A.D.
1893 and having been severally
sworn or affirmed as per within
order we have viewed the ground
at the said bridge, and the bridge
already built by Lawrence Township
and are of opinion that the erection
of the same, since it is a bridge
of only about sixteen feet span
and rather inferior masonry
in abutments, has not been
