To the Hon. Cyrus Gordon, President Judge of said County:-

The petition of the undersigned citizens of the Township of Cooper in said County, respectively represents:-

That a petition was presented to your Honor alleging that the inhabitants of said Township were laboring under great inconvenience for want of a public road or high-way, " to lead from the road leading to German Settlement at or near the line between James L. Stewart and O.L. Hughes to the old cabin on the Winburne road," and praying that viewers should be appointed to view and report upon the same;

That John Stephenson, A.C. Dale and J.L. Ward were, on the 21st, day of December 1894, appointed viewers who filed their report on the 6th, day of February 1894 by which a road, between the said points, is laid out and recommended to be opened.

That in the opinion of your petitioners, ^{it} is not necessary for public use, is not laid over the best or most practicable route between the two points, and the construction and maintenance of the same will entail a greater expense upon the Township than the usefulness of the road will warrant. They would therefore respectively request the Court will refuse to confirm the report viewers as filed and that they will have pray, etc.
