County.

The undersigned petitioners residents
and tax payers of Bell Township in
said County respectfully represents:

That the County of
Clearfield assisted the Township of
Bell in the year 1904 in building
what is known as the "old" Bridge
over Chestnut Creek near McHappy. Pa.
the County of Clearfield furnishing
the "iron" or superstructure and also
gave \$2886.58 towards the erection of
the abutments of said Bridge.

That said
Bridge is 150 feet of span in the clear.

Your petitioners would
further represent that the care main-
tenance and responsibility of said
Bridge is greater than it is reasonable
that the said Township should bear
and that said bridge is in need of
painting and repairs. soon as
the travel on the same is very large.

County Bridge by the County Commission
of Clearfield County as provided by
Act April 28. 1899. P.L. 91
