P E T I T I O N

TO THE ROAD SUPERVISORS OF LAWRENCE TOWNSHIP:

The undersigned Petitioners petition the Supervisors of
Lawrence Township as follows:

1. The undersigned Petitioners respectfully request the
Board of Supervisors of Lawrence Township to take over and open
the street, to be designated *Fleck* Street, from L.R.
17120 for a distance of approximately 730 feet.
2. The said proposed street has a center line of North
26° 8' East from its intersection with L.R. 17120 and a distance
of approximately 730 feet, said street being 40 feet in width
and being 20 feet on either side of said center line.
3. The said street has been utilized by the public for a
period exceeding twenty-five years and has been maintained by the
Township of Lawrence.
4. That the undersigned, as sole owners of all real
estate adjoining or abutting the said proposed road, do hereby
dedicate, grant, convey and release unto the Road District of
Lawrence Township, all of their right, title and interest, as
encompassed by the proposed 40 foot wide street, which is the

subject of this Petition, and we further release the Supervisors of Lawrence Township from any liability, compensation or monies that may be incurred in the opening and extending of the proposed 40 foot street for a distance of approximately 730 feet in length.

5. That your Petitioners request that the said Street be opened and made a part of the Township Road System.

WHEREAS, a Petition has been presented by all adjoining and abutting land owners, to the Supervisors of Lawrence Township, requesting that a street (to be designated *Fleck* Street) be taken over and opened from the intersection of L.R. 17120, the center line of which is North 26° 8' East a distance of approximately 730 feet, more or less, with said street having a uniform width of 40 feet, and

WHEREAS, *Fleck* Street has been utilized for more than 25 years by the public and maintained by the Township of Lawrence and it is also the desire of the Board of Supervisors of the Township of Lawrence, to accept and incorporate said *Fleck* Street in accordance with the Petition presented, into the said Township Road System.

NOW, THEREFORE, BE IT RESOLVED:

1. That a street (herein named *Fleck* Street) having a uniform width of 40 feet be herewith opened and taken

into the Road System of Lawrence Township, the center line of which is North 26° 8' East from its intersection with L.R. 17120 a distance of 730 feet, more or less, in accordance with map attached to this Resolution.
