FIRST: That James K. Nevling and Raymond S. Walker are the owners of a parcel of land situate in Bradford Township, Clearfield County through which a portion of Township Route No. T-617 passes.

SECOND: That the Bradford Township Supervisors wish to vacate a portion of Township Route No. T-617, said portion passing through the above tract.


THIRD: That Bradford Township Supervisors have entered into an agreement dated March 9<sup>th</sup>, 1976 with James K. Nevling and Raymond S.
