AND NOW, this 1st day of February, 1982, after hearing held on the Petition of the Board of Commissioners of Clearfield County to establish a county road to be located at the Clearfield County Jail property in Lawrence Township, Clearfield County, Pennsylvania, and evidence having been submitted of the publication of a notice of this hearing in the Clearfield Progress on the 20th day of January, 1982, and in the DuBois Courier Express on the 19th day of January, 1982, all being in excess of ten (10) days of said hearing, and it further appearing that said road is to be located entirely upon lands owned by the County of Clearfield, including the present site of said existing road and entirely surrounding said Clearfield County Jail, in that no persons or parties having appeared to object to the establishment of said road, and that funding for the adoption of said road and the improvements thereon are to be paid solely from the liquid fuel allocation of the Commonwealth of Pennsylvania, IT IS HEREBY ORDERED AND DECREED that the Petition for the Establishment of said County Road is hereby approved.

PETITION FOR APPROVAL OF THE ESTABLISHMENT  
OF A COUNTY ROAD

TO THE HONORABLE JOHN K. REILLY, JR., PRESIDENT JUDGE OF SAID  
COURT:

The Board of Commissioners of the County of Clearfield  
respectfully represent as follows:

1. That your Petitioners are the duly elected Board  
of Commissioners of the County of Clearfield, Pennsylvania.
2. That the County is the owner of a certain tract of  
land situate in Lawrence Township, Clearfield County, Pennsylvania,  
upon which is situate the Clearfield County Jail.
3. That there is presently located upon said premises  
an access road serving said premises and upon lands owned by the  
County of Clearfield and which said road has been improved in con-  
nection with the construction of the Clearfield County Jail.
4. That there is attached to this Petition and incorporated  
herein by reference the following:
  - (a) Exhibit "A" - legal description of the  
proposed County road.
  - (b) Exhibit "B" - a map showing the location  
of the County road.
5. That the adoption of said road as a County road by the  
County of Clearfield has been presented by your Petitioners to the  
Pennsylvania Department of Transportation, and subject to the approval

of your Honorable Court of the adoption of said road as a county road, the Pennsylvania Department of Transportation has agreed to qualify said road and the improvements thereon under the Liquid Fuels allocation, so that construction costs may be recouped and repairs made solely from Liquid Fuel allocations now and in the future.

WHEREFORE, your Petitioners respectfully request your Honorable Court to approve the establishment of said road as a county road, as is authorized by the County Code, Act of August 9, 1955, P.L. 323 §2740 (16 P.S. §2740).

Front Access Road

Beginning at a point, said point being the centerline of the front access road to the Clearfield County Jail and the centerline of Lawrence Township Road Number T-591; thence with the centerline of said access road S 43°, 46' E a distance of 77.5 feet to a point of curvature; thence with a curve to the right with a delta angle of 73 degrees and a radius of 62 feet, having an arc distance of 78.99 feet; to a point; thence N 60° 46' W a distance of 5 feet to a point in the centerline of said access road and a point of curvature; thence with a curve to the left, with a delta angle of 44° 30' and a radius of 43 feet, having an arc distance of 33.50 feet to a point of tangency; thence S 15° 16' E a distance of 223.11 feet to a point of curvature; thence with a curve to the left, with a delta angle of 135 degrees and a radius of 28 feet, having an arc distance of 65.97 feet to a point of tangency; thence N 29° 44' E a distance of 143.53 feet to a point of curvature; thence with a curve to the left, with a delta angle of 90 degrees, and a radius of 33 feet, having an arc distance of 51.84 feet to a point of tangency, thence N 60° 16' W a distance of 134.41 feet to a point of curvature; thence with a curve to the right, with a delta angle of 59 degrees and a radius of 57 feet, having an arc distance of 58.70 feet to a point; thence S 88° 44' W a distance of 5 feet to a point on the first curve, said point being 123.49 feet from the point of beginning. There is 1581 square yards of paving, variable in width from 14 feet to 24 feet. The total length of the roadway being 867.45 feet or 164 miles.

Rear Access Road

Beginning at a point, said point being the centerline of the rear access road to the Clearfield County Jail and the centerline of Lawrence Township Road Number T-591; thence with the centerline of said road S 43° 46' E a distance of 53.50 feet to a point of curvature; thence with a curve to the right, with a delta angle of 27 degrees and 6 minutes and a radius of 248.96 feet, having an arc distance of 117.75 feet to a point of tangency; thence S 16° 40' E a distance of 310 feet, more or less, to a point at the edge of paving.

There is 1092 square yards of paving, with a 20 foot width and 481 feet in length. .091 miles.

REAR ACCESS ROAD

SPUR "A"

Beginning at a point, said point being on the centerline of the rear access road, (Station 4+23) and the centerline of spur A (Station 0+00); thence N 73° 20' E a distance of 45 feet to a point of curvature; thence with a curve to the left, with a delta angle of 90 degrees and a radius of 25 feet, having an arc distance of 39.27 feet to a point of tangency; thence N 16° 40' W a distance of 110.73 feet to a point of curvature; thence with a curve to the left, with a delta angle of 72 degrees 30 minutes and a radius of 40 feet, having an arc distance of 50.61 feet to a point of curvature on a reverse curve; thence with a curve to the right, with a delta angle of 72 degrees 30 minutes and a radius of 60 feet, having an arc distance of 75.92 feet to a point of tangency on the centerline of the rear access road (Station 1+91.90) = (Station 3+21.53 "Spur A").

There is 858 square yards of paving, variable in width. The total length of roadway is 321.53 feet .061 miles.


