REPORT OF THE BOARD OF SUPERVISORS OF BRADFORD  
TOWNSHIP, CLEARFIELD COUNTY, PENNSYLVANIA

---

TO: The Honorable Court,

The Board of Supervisors of Bradford Township, Clearfield  
County, Pennsylvania, respectfully represents as follows:

1. That they are the duly elected Supervisors of  
Bradford Township, Clearfield County, Pennsylvania.

2. That the portions of the roads to be affected are  
as follows:

(a) The section of Route No.168 extending from  
the intersection of Route No.168 with Route  
No.150 in a northeasterly direction toward  
Interstate Route No.80 a distance of approxi-  
mately one-tenth (.1) of a mile to a point

where it dead ends is vacated.

(b) The section of Route No.150 extending from a point near the real estate known as the Bradford Independent School site in a northeasterly direction toward Interstate Route No.80., commonly known as the Pennsylvania Shortway, a distance of approximately one-tenth (.1) of a mile as described in Ordinance No.32 is reopened and retaken as a township road.

3. That attached hereto and made a part hereof and marked Exhibit "A" is a draft from the Plot of County Roads in that area showing the two roads; Route No.168 being marked in green and Route No.150 being marked in red.

4. That in the opinion of the Board of Supervisors it is necessary to vacate the one-tenth (.1) of a mile of Route No.168, the same having become useless and of no value to the taxpayer and the public generally.

5. That it is necessary in the judgment of the Board of Supervisors that for the benefit of the taxpayers and the public it is necessary to reopen and retake the stretch of Route No.150, which was previously vacated by Ordinance No.32, adopted

July 1, 1970.

6. That the only abutting property owner to both of these parcels is Geynet Lansberry, who was personally served with a copy of a Notice with the proposed enactment of an Ordinance affecting these two tracts. A copy of said Notice is attached hereto and made a part of this report designated as Exhibit "B".

7. That personal service of said Notice was given to Geynet Lansberry by Certified Mail, Return Receipt on August 9 , 1982.

8. That pursuant to said Notice and following advertisement as required by law, the Board of Supervisors of Bradford Township did enact an Ordinance, a copy of which is attached hereto as Exhibit "C" on September 7, 1982.

9. That prior to the enactment of said Ordinance, a meeting was held at the Township Building, Bradford Township, on September 6, 1982 at 7:00 P.M. at which time no objections to the proposed vacating or retaking of said roads were raised.


WHEREFORE, the Board of Supervisors of Bradford Township, Clearfield County, Pennsylvania would request your Honorable Court



Notice of proposed vacating of One-tenth (.1) of a mile of Route 168 and the opening and taking of One-tenth (.1) of a mile of Former Route No.150.

TO: GEYNET LANSBERRY,

NOTICE is hereby given that the Supervisors of the Township of Bradford will meet at the regular place of meeting in the Township on the 7th day of September, 1982 at 7:00 o'clock P.M., at which time action will be taken upon:

(a) Section of Route No.168 extending from the intersection of Route No.168 with Route No.150 in a northeasterly direction toward Interstate Route No.80 a distance of approximately one-tenth (.1) of a mile to a point where it dead ends;

(b) and the opening and taking of the section of Route No.150 extending from a point near the real estate known as the Bradford Independent School site in a northeasterly direction toward Interstate Route No.80, commonly known as the Pennsylvania Shortway, a distance of approximately one-tenth (.1) of a mile.

YOU are hereby notified that you may appear at that time and place and present your position on the proposed action.

ORDINANCE NO. \_\_\_\_\_

AN ORDINANCE OF THE BOARD OF SUPERVISORS OF BRADFORD TOWNSHIP, CLEARFIELD COUNTY, PENNSYLVANIA, VACATING ONE-TENTH (.1) OF A MILE OF ROUTE NO.168 AS A TOWNSHIP ROAD AND OPENING AND TAKING ONE-TENTH (.1) OF A MILE OF FORMER ROUTE NO.150 AS A TOWNSHIP ROAD.

The Board of Supervisors of Bradford Township, Clearfield County, Pennsylvania, enacts and ordains as follows:

SECTION I

DECLARATION OF PURPOSE

Section 1.01. WHEREAS, Section 66101 of The Second Class Township Code (53 P.S. §66101) permits township supervisors to enact, ordain, survey, lay out, open, widen, straighten, vacate and relay all roads within the township; and

Section 1.02. WHEREAS, it is necessary in the judgment of the Board of Supervisors to vacate one-tenth (.1) of a mile of Route No.168 the same having become useless and of no value to the taxpayers and the public generally; and

Section 1.03. WHEREAS, by Ordinance No.32 adopted July 1, 1970 and further listed in the Office of the Clerk of Court in Road Docket 7, Page 427, the township vacated one-tenth (.1) of a mile of Route No.150; and

Section 1.04. WHEREAS, it is necessary in the judgment of the Board of Supervisors to reopen and take that same stretch of Route No.150.

SECTION II

VACATION AND OPENING

Section 2.01. The Section of Route No.168 extending from the intersection of Route No.168 with Route No.150 in a northeasterly direction toward Interstate Route No.80 a distance of approximately one-tenth (.1) of a mile to a point where it dead ends is hereby vacated.

Section 2.02. The section of Route No.150 extending from a point near the real estate known as the Bradford Independent School site in a northeasterly direction toward Interstate Route No.80, commonly known as the Pennsylvania Shortway, a distance of approximately one-tenth (.1) of a mile as described in Ordinance No.32 is hereby reopened and retaken as a township road.

SECTION III

EFFECTIVE DATE



Section 3.01. This Ordinance shall become effective five (5) days after the date of enactment.






