RESOLUTION NO. <sup>114</sup>

WHEREAS, the Township of Morris, Clearfield County, Pennsylvania, has maintained certain roads hereinafter described for a period in excess of twenty-one (21) years, and

WHEREAS, the Township of Morris desires to include said roads in the official Township Road system.

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF SUPERVISORS OF THE TOWNSHIP OF MORRIS, Clearfield County, Pennsylvania, and it is hereby enacted by authority of the same:

1. The following roads are hereby declared to be Township roads and are hereby included in the Township Road system of Morris Township to be maintained as such:

(a) A road which begins at the northernmost point of existing township road no. T-245 and extends in a northerly direction a distance of Two Hundred Twenty-six (226') feet to the point of intersection with Pa. State Legislative Route 17103.

(b) A road which begins at the intersection of Pa. Legislative Route No. 17103 and Township Road T-245 and extends in a Southerly direction a distance of Six Hundred Fifty-seven (657') feet to the point of intersection with Township Road T-683 and Township Road T-690.

(c) A road which begins at the northernmost point of existing Township Road T-682 and extends in a northerly direction a distance of Seven Hundred

Seventy-five (775') feet to the point of intersection with Pa. State Legislative Route No. 17060.




