AN ORDINANCE OF THE TOWNSHIP OF LAWRENCE 114  
VACATING A PORTION OF FRANK STREET LOCATED IN  
LAWRENCE TOWNSHIP, CLEARFIELD COUNTY, PENNSYL-  
VANIA, WHICH EXTENDS FROM RIVER ROAD TO FRONT  
STREET IN A NORTHWESTERLY DIRECTION FOR A  
DISTANCE OF APPROXIMATELY 299.54 FEET, MORE OR  
LESS.

WHEREAS, Clifton C. Houtz has requested that the portion  
of Frank Street located in Lawrence Township, Clearfield County,  
Pennsylvania, which extends from River Road to Front Street in a  
northwesterly direction for a distance of approximately 299.54 feet,  
more or less, be vacated, and

WHEREAS, the Board of Supervisors of the Township of  
Lawrence held a public hearing on September 19, 1984, following  
notices duly sent to all abutting and adjoining land owners and  
notice published in the Progress newspaper on September 6, 1984, at  
which no objections to the vacation were raised, and

WHEREAS, the Board of Supervisors of the Township of  
Lawrence, after the public hearing, are of the opinion that the said  
portion of Frank Street to be vacated has become useless, incon-  
venient and burdensome.

NOW THEREFORE, BE IT ORDAINED BY THE TOWNSHIP OF LAWRENCE  
AS FOLLOWS:

Section 1. That the portion of Frank Street located in  
the Township of Lawrence, Clearfield County, Pennsylvania from

River Road to Front Street for a distance of 299.54 feet, more or less, more specifically described as follows:

BEGINNING at the Northwest intersection of River Road and Frank Street; thence in a northwesterly direction for a distance of 205 feet more or less to a point; thence in a northeasterly direction for a distance of sixteen feet more or less to a point; thence in a northwesterly direction for a distance of eighty five feet more or less to a point; thence in a southwesterly direction for a distance of sixteen feet more or less to a point; thence in a northwesterly direction for a distance of ten feet to the southwesterly intersection of Front Street and Frank Street; thence in a northeasterly direction for a distance of thirty feet to the southeasterly intersection of Front Street and Frank Street; thence in a Southeasterly direction for a distance of 299.54 feet more or less to the northeasterly intersection of Frank Street and River Road; thence in a southwesterly direction for a distance of thirty feet to place of beginning.

be vacated and removed from the Lawrence Township Road System. A plot plan setting forth said Frank Street is on file in the Clearfield County Recorder of Deeds Office in Miscellaneous Book No. 35, page 157.
