REPORT OF THE BOARD OF SUPERVISORS OF BRADFORD
TOWNSHIP, CLEARFIELD COUNTY, PENNSYLVANIA

TO THE HONORABLE COURT:

The Board of Supervisors of Bradford Township, Clearfield County, Pennsylvania, respectfully represents as follows:

1. That they are the duly elected Supervisors of Bradford Township, Clearfield County, Pennsylvania.
2. That the portion of roadway affected is as follows:
 - (a) The Section of Township Route No. 603 beginning at a point approximately 2,057 feet from the intersection of Township Route No. 603 and Route No. 167 and extending a distance of approximately 2,019 feet to a point where it dead ends.
 - (b) That attached hereto and made a part hereof and marked "Exhibit A" is a draft from the Township Road map with the area being vacated being marked in red.

3. That in the opinion of the Board of Supervisors, and pursuant to the request of the sole property owner, it is advantageous to the Township to vacate the approximately 2,019 feet of Township Route No. 603, the same having become useless and of no value to the taxpayers and the public generally.

4. That the only abutting property owner is Mrs. Grace M. Lansberry, who was personally served with a copy of a Notice on the proposed enactment of the Ordinance affecting said roadway. A copy of said Notice is attached hereto and made part of this Report designated as "Exhibit B".

5. That personal service of said Notice was given to Mrs. Grace M. Lansberry on June 20, 1985, by Supervisor Howard Smith.

6. That pursuant to said Notice and following advertisement, as required by law, the Board of Supervisors of Bradford Township did enact an Ordinance No. 185, copy of which is attached hereto as "Exhibit C" on July 2, 1985.


7. That prior to the enactment of said Ordinance, a meeting was held at the Township Building, Bradford Township, on

July 2, 1985, at 7:00 p.m., at which time no objections to the proposed vacating of said roadway was raised.



ORDINANCE NO. 185

AN ORDINANCE OF THE BOARD OF SUPERVISORS OF BRADFORD TOWNSHIP, CLEARFIELD COUNTY, PENNSYLVANIA, VACATING APPROXIMATELY 2,019 FEET OF TOWNSHIP ROAD NO. 603.

The Board of Supervisors of Bradford Township, Clearfield County, Pennsylvania, enacts and ordains as follows:

SECTION I

DECLARATION OF PURPOSE

Section 1.01: WHEREAS, Section 1101 of The Second Class Township Code (53 P.S. §66101) permits township supervisors to enact, ordain, survey, lay out, open, widen, straighten, vacate and relay all roads within the township; and,

Section 1.02: WHEREAS, the Board of Supervisors has been requested by the property owner to vacate approximately 2,019 feet of Township Route No. 603; and,

Section 1.03: WHEREAS, said vacation is, in the judgment in this Board of Supervisors, merited as said Route is a dead end making the same useless and of no value to the taxpayers and the public generally.

SECTION II

VACATION

Section 2.01: The Section of Township Route No. 603 beginning at a point approximately 2,057 feet from the intersection of Township Route No. 603 and Route No. 167 and extending a distance of approximately 2,019 feet to a point where it dead ends is hereby vacated.

SECTION III

EFFECTIVE DATE

Section 3.01: This Ordinance shall become effective five (5) days after the date of enactment.


