REPORT OF THE BOARD OF SUPERVISORS OF DECATUR
TOWNSHIP, CLEARFIELD COUNTY, PENNSYLVANIA

TO THE HONORABLE COURT:

The Board of Supervisors of Decatur Township, Clearfield
County, Pennsylvania, respectfully represents as follows:

1. That they are the duly elected Supervisors of
Decatur Township, Clearfield County, Pennsylvania.

2. That the roadway to be layed out and opened is as
follows:

(a) Beginning at a point on Route No. 970 and
extending in a north west direction approximately 2200
feet along the southern boundary of the
Mabel McClure property, which line also runs along
the Boggs Township line; thence proceeding
south west through property of Ivan and Bessie
Kramer, a distance of approximately 550 feet to
the Goss Cemetery property. Said roadway and
right-of-way to be a width of 33 feet along its
entire course.

(b) That attached hereto and made a part here-
of and marked "Exhibit A" is a draft from the
County Assessment Maps with the area being laid
out and opened and being marked in red.

3. That in the judgment of the Board of Supervisors, and
in line with requests from township citizens, dating back to 1968,

it is advantageous to the Township to open and lay out a road to permit access by the citizens of the township and the public to the Goss Cemetery.

4. That the effected property owners are Ivan and Bessie Kramer and Mabel McClure, who have been served with a copy of Notice on the proposed enactment of the Ordinance affecting said roadway. A copy of said Notice is attached hereto and made a part of this Report designated as "Exhibit B".

5. That service of said Notice was given to Ivan and Bessie Kramer by Mr. Raymond Showers on September 9 , 1985.

6. That service of said Notice was made on Mabel McClure on September 9, 1985 by Certified Mail.

7. That pursuant to said Notice and following advertisement, as required by law, the Board of Supervisors of Decatur Township did enact an Ordinance No. 44 , copy of which is attached hereto as "Exhibit C" on September 24 , 1985.



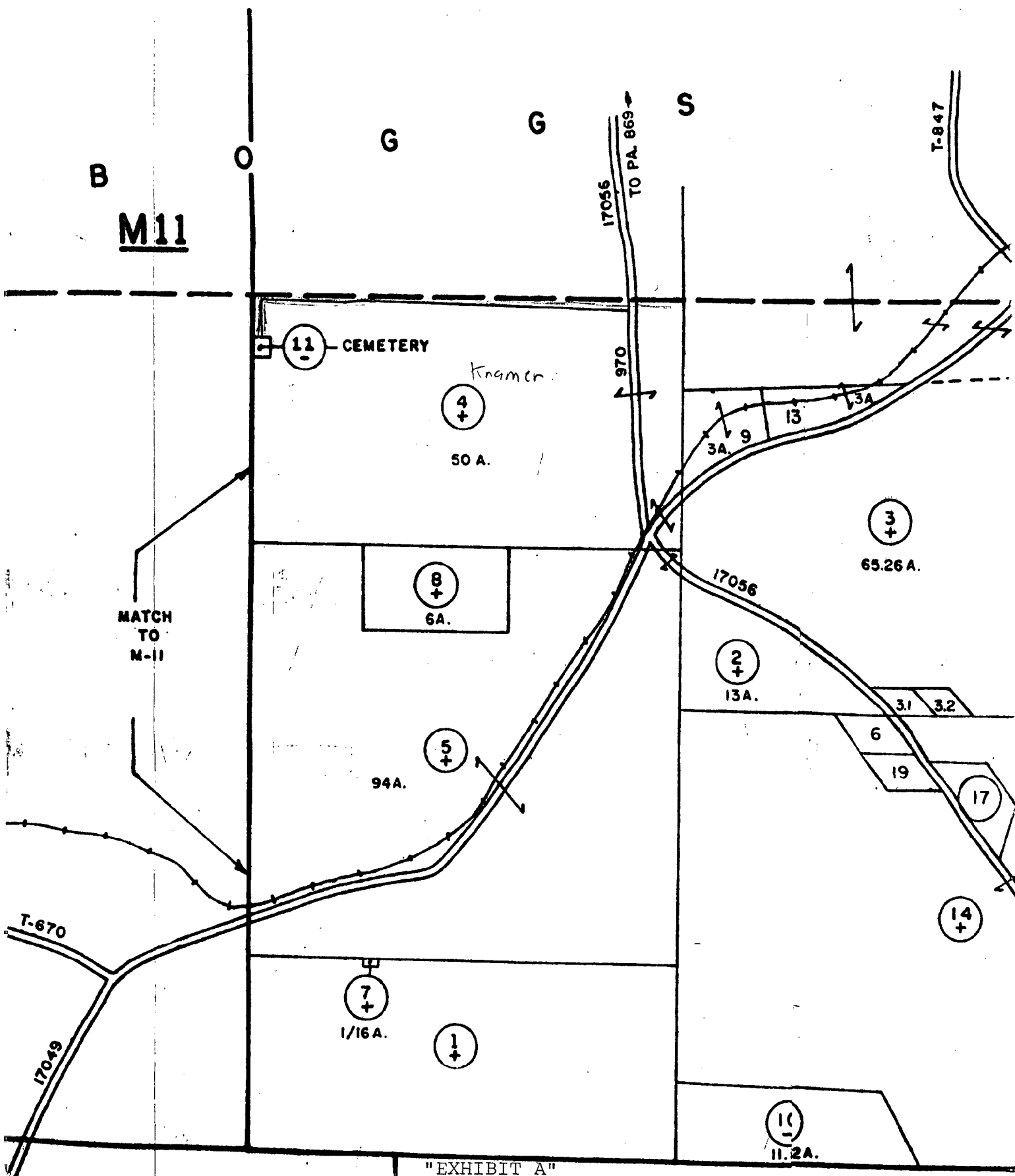

ORDINANCE NO. 44

AN ORDINANCE OF THE BOARD OF SUPERVISORS OF DECATUR TOWNSHIP, CLEARFIELD COUNTY, PENNSYLVANIA, LAYING OUT AND OPENING A TOWNSHIP ROADWAY TO BE KNOWN AS TOWNSHIP ROUTE NO. 672.

The Board of Supervisors of Decatur Township, Clearfield County, Pennsylvania, enacts and ordains as follows:

SECTION I

DECLARATION OF PURPOSE

Section 1.01: WHEREAS, Section 1101 of The Second Class Township Code (53 P. S. §66101) permits township supervisors to enact, ordain, survey, lay out, open, widen, straighten, vacate and relay all roads within the township; and,

Section 1.02: WHEREAS, under proceeding filed to No.1, February Term, 1968 in the Court of Common Pleas of Clearfield County, citizens of the township had petitioned for the opening of a road to the Goss Cemetery; and,

Section 1.03: WHEREAS, at the time of said petition, conditions did not make feasible the opening of a township road as requested; and,

Section 1.04: WHEREAS, conditions in the area now make feasible the opening of a township road to the Goss Cemetery; and,

Section 1.05: WHEREAS, in the judgment of this Board of Supervisors, said opening and laying out of a roadway to the Goss Cemetery is of value to the citizens of the township and the public generally.

SECTION II

OPENING AND LAYING OUT

Section 2.01: That the township does hereby take, lay out and open a roadway to be known as Township Route No. 672 Beginning at

a point on Route No. 970 and extending in a north west direction approximately 2200 feet along the southern boundary of the Mabel McClure property, which line also runs along the Boggs Township line; thence proceeding south west through property of Ivan and Bessie Kramer, a distance of approximately 550 feet to the Goss Cemetery property. Said roadway and right-of-way to be a width of 33 feet along its entire course.

SECTION III

EFFECTIVE DATE

Section 3.01: This Ordinance shall become effective five (5) days after the date of enactment.
