AN ORDINANCE OF THE TOWNSHIP OF LAWRENCE TO OPEN
AND INCORPORATE INTO THE LAWRENCE TOWNSHIP ROAD
SYSTEM A ROAD TO BE NAMED TURNER DRIVE SAID ROAD
TO EXTEND FROM THE NORTHERN LINE OF TOWNSHIP ROAD
T599 A DISTANCE OF 562 FEET HAVING A UNIFORM WIDTH
OF 33 FEET.

WHEREAS, A Petition has been presented by the adjoining and
abutting land owners and their respective spouses who are the owners
of the real estate abutting on both sides of a proposed Township Road
requesting that the Board of Supervisors open and incorporate into the
Township Road System said proposed road for a distance of 562 feet in
length from the northern line of T599 to the line of land of Bert R.
Ross and Linda J. Ross property, having a uniform width of 33 feet
in accordance with the survey attached hereto; and

WHEREAS, the Board of Supervisors of the Township of Lawrence
held a public hearing on October 9, 1985, following notices which were
duly sent to all abutting and adjoining land owners and notice published
in the Progress newspaper on September 27, 1985, at which no objections
to said purposed road were raised, and

WHEREAS, it is the desire of the Board of Supervisors to
open said road for the distance of 562 feet having a uniform width of
33 feet and incorporate the same into the Township Road System as per
the survey attached hereto.

NOW THEREFORE, BE IT ENACTED AND ORDAINED AS FOLLOWS:

Section 1. Said proposed road or street is hereby opened
and incorporated into the Lawrence Township Road System from the

northern line of T599, a distance of 562 feet, to the property line of Bert R. Ross and Linda J. Ross, which street or road shall have a right of way of 33 feet in accordance with a survey attached hereto as exhibit A.

Section 2. Said roadway is hereby named and designated Turner Drive.

Section 3. Said roadway shall not be paved nor shall any other improvements be made thereto unless a majority of the owners abutting said street petition for said pavement and/or improvement and agree to pay a front footage assessment and pro-rata share of the costs; provided that, nothing herein shall be construed so as to bind the Township of Lawrence to pave or make any improvements to said roadway.
