ORDINANCE 12

TOWNSHIP OF GOSHEN 113  
CLEARFIELD COUNTY, PENNSYLVANIA

AN ORDINANCE VACATING A PORTION OF TOWNSHIP ROUTE 636  
EXTENDING APPROXIMATELY 400 FEET SOUTH OF PENNSYLVANIA  
ROUTE 879

WHEREAS, the section of Goshen Township Route 636, 16 feet in width (33 1/2 foot right of way) and extending approximately 400 feet South of Pennsylvania Route 879 is not considered necessary or useful for the convenience of the general public; and

WHEREAS, the bridge over which the aforescribed section of said Township Road ran has been removed thereby making said portion of Goshen Township Route 636 impassible; and

WHEREAS, the aforescribed section of Goshen Township Route 636 is a liability to the Township of Goshen in the care and maintenance thereof; and

WHEREAS, at least ten days' written notice of the date of the meeting whereby this Ordinance was to be considered and enacted, was given to any affected property owners; and

WHEREAS, a public hearing has been held on the question of the vacation of the aforescribed section of Goshen Township Route 636 in conformity with Section 1102 of the Second Class Township Code, as amended; and

WHEREAS, in the judgment of the Board of Supervisors,

the aforescribed section of Goshen Township Route 636 serves no useful purpose or public convenience

NOW, THEREFORE, BE IT ORDAINED AND ENACTED by the Board of Supervisors of Goshen Township, Clearfield County, Pennsylvania, under and by authority of Section 1101 of the Second Class Township Code, as amended, IT IS HEREBY ENACTED AND ORDAINED as follows:

Section I

That the section of Goshen Township Route 636, as laid out 16 feet in width (33 1/2 foot right of way), extending approximately 400 feet South of Pennsylvania Route 879 be vacated as a public highway and that all the right, title and interest of the Township of Goshen therein is hereby divested.

Section II

That the proper officers of the Township are authorized and directed to make a draft or survey of the aforescribed section of Goshen Township Route 636 herein vacated including therewith the names of the owners of property abutting thereon, and file the same with an attested copy of the Ordinance on behalf of the Township in the office of the Clerk of the Court of Quarter Sessions of Clearfield County.

Section III

That the Solicitor of the Township shall give written notice of this action to the abutting property owners within ten

(10) days of the adoption of this Ordinance.

Section IV

If no exceptions are filed in the court of Quarter Sessions within thirty (30) days after the date of the filing of the Ordinance provided in Section II hereof, the Township Secretary shall cause Goshen Township Route 636 as above described to be stricken from the plan of the highways of Goshen Township, and thereafter, no Township moneys shall be expended or materials used in the maintenance and the care of said road, and all Township jurisdiction thereto shall cease and terminate.

ORDINANCE NO. 17TOWNSHIP OF GOSHEN  
CLEARFIELD COUNTY, PENNSYLVANIAORDINANCE AMENDING ORDINANCE NO. 12 OF GOSHEN TOWNSHIP,  
CLEARFIELD COUNTY, PENNSYLVANIA.Section I.

Section I of Ordinance No. 12 of the Township of Goshen, Clearfield County, Pennsylvania, is amended to read as follows:

## Section I

That the section of Goshen Township Route 636, as laid out 16 feet in width (33 1/2 foot right of way), extending approximately 4 tenths (.4) of a mile South of Pennsylvania Route 879 be vacated as a public highway and that all the right, title and interest of the Township of Goshen therein is hereby divested.

Section II.

Any ordinances or parts of ordinances inconsistent herewith are hereby repealed.

Section III.

This ordinance shall become effective five (5) days after adoption.
