ORDINANCE NO. 25  
BIGLER TOWNSHIP  
CLEARFIELD COUNTY, PENNSYLVANIA

Be it ordained, adopted and enacted by the Township Supervisors of Bigler Township, Clearfield County, Pennsylvania, as follows:

Section 1. This Ordinance shall be known as the Ordinance opening a portion of Centre Street, located in the Village of Smoke Run, Bigler Township, Clearfield County, Pennsylvania.

Section 2. The said portion of Centre Street to be opened under this Ordinance is described as follows:

BEGINNING at a tack in hub in the center line of the proposed township road and on the northern right of way line of State Highway Route Number A. 5508 and said point of beginning being South sixty one degrees thirty minutes West (S 61° 30' W) a distance of twenty five and no hundredths (25.00') feet from the existing Southwest iron pipe corner of Raymond Lukens as set by others and said point of beginning being these two following courses and distances from State Highway Station-25 (Route Number A. 5508) as existing and located June 9, 1983; North sixty four degrees forty three minutes East (N 64° 43' E) a distance of three hundred five and onetenth (305.1') feet more or less; thence North twenty eight degrees thirty minutes West (N 28° 30' W) a distance of sixteen and forty seven hundredths (16.47') feet to the point of beginning; thence along the center line of the proposed Township road North twenty eight degrees thirty minutes West (N 28° 30' W) a distance of three hundred twenty two and fifty five hundredths (322.55') feet to a tack in a hub the terminus and said terminus point being South twenty eight degrees thirty minutes East (S 28° 30' E) a distance of sixteen and fifty hundredths (16.50') feet from the center line of existing Township Road Number TR-833. Said proposed Township Road having a width of thirty three and no hundredths (33.00') feet with sixteen and fifty hundredths (16.50') feet on either side of the above described center line and parallel therewith throughout its entire length. Situate in the Village of Smoke Run, Bigler Township, Clearfield County, Pennsylvania.

Section 3. Any and all ordinances inconsistent with this Ordinance of Bigler Township, Clearfield County, Pennsylvania, are hereby repealed.

Ordained, adopted and enacted by the Township Supervisors of Bigler Township, Clearfield County, Pennsylvania, this 7th day of November, 1983.

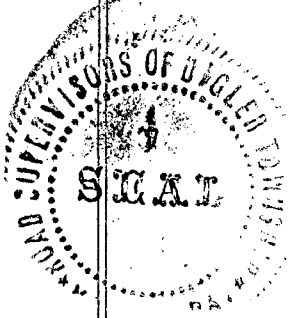

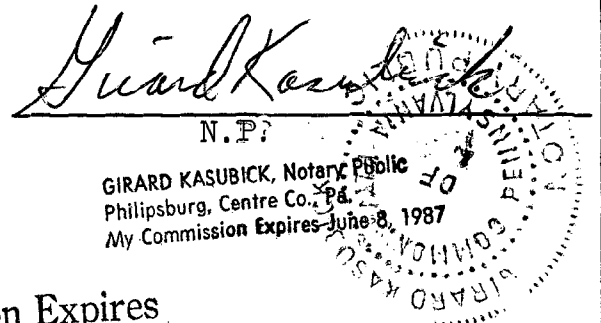
