TO WHOM IT MAY CONCERN:

I, BERNARD ANTHONY JOHNSON, administrator of the John William and Mary Elizabeth Johnson Estates do hereby grant to the Decatur Township Road Board a right of way along Decatur Township Road 669 not to exceed six and one half feet (6½ ft) in width and seven hundred and nineteen (719 ft) in length to facilitate construction of a township road from Pennsylvania Route 53 to Pennsylvania Legislative Route 17058 in Decatur Township.

The amount of compensation for this property right of way is negotiable, will be within reasonable property values now prevailing and will be negotiated between the Decatur Township Supervisors and BERNARD ANTHONY Johnson, administrator of the John William and Mary Elizabeth Johnson Estates.

This agreement is applicable only to the right of way involving the property mentioned above.

DGRANT OF RIGHT-OF-WAY

WE, the undersigned, are the owners of property transversed by a certain road in Decatur Township, Clearfield County, Pennsylvania, and do hereby acknowledge receipt of notice less than ten (10) days written notice that a hearing will be held in the Decatur Township Building, Osceola Mills, R.D., Pennsylvania, at the regular meeting of The Board of Supervisors of Decatur Township on the 12th day of June, 1979, at 7:00 P.M., to determine whether said road shall be taken over by Decatur Township as a Township Road to be described as follows:

BEGINNING at a P.K. nail in the centerline of an existing twenty (20.00') foot right-of-way and the centerline of proposed Township Road and said P.K. nail being on the Northern side of the paved portion of State Highway Route No. 53 and said P.K. nail being these following two courses and distances from an iron pin corner on property line between I. and M. Body Shop (Butterworth) and Barletta Grocery Company, Inc., South fifty eight degrees twenty-seven minutes West ($S\ 58^{\circ}\ 27'W$) a distance of one hundred thirty three and no hundredths (133.00'); thence South sixty one degrees twenty five minutes West ($S\ 61^{\circ}\ 25'W$) a distance of two hundred sixty four and twenty five hundredths (264.25') feet; and also being South seventy three degrees fifty minutes West ($S\ 73^{\circ}\ 50'W$) a distance of one hundred eighty nine and fifty hundredths (189.50') feet from Highway Station one over eighty on Route No. 53 as located on Nov. 6, 1978; thence along the centerline of the existing twenty (20.00') foot right-of-way and the centerline of the proposed Township Road, North fifty degrees ten minutes West ($N\ 50^{\circ}\ 10'W$) a distance of four hundred seven and no hundredths (407.00') feet to a railroad spike, said portion of proposed Township Road having a length of four hundred seven and no hundredths (407.00') feet with a width of thirty eight and fifty hundredths (38.50') feet with twenty two and no hundredths (22.00') feet on the right side of said centerline and sixteen and fifty hundredths (16.50') feet on the left side of said centerline; thence by same North fifty one degrees twenty three minutes West ($N\ 51^{\circ}\ 23'W$) a distance of sixty five and no hundredths (65.00') feet to a railroad spike; thence still by same North fifty five degrees fifty minutes West ($N\ 55^{\circ}\ 50'W$) a distance of eight hundred sixty and ninety hundredths (860.90') feet to a railroad spike; thence still by same North fifty three degrees fifty six minutes West ($N\ 53^{\circ}\ 56'W$) a distance of

two hundred ninety one and ninety hundredths (291.90') feet to a railroad spike in said centerline. This portion of proposed Township Road having a length of one thousand two hundred seventeen and eighty hundredths (1217.80') feet with a width of thirty three and no hundredths (33.00') feet with sixteen and fifty hundredths (16.50') feet on either side of the above described centerline. Said proposed Township Road having a total length of one thousand six hundred twenty four and eighty hundredths (1624.80') feet with widths as above described.

Situate in Decatur Township, Clearfield County, PA.

Copy of the map of the above described road being on file for public examination at the Decatur Township Building, Osceola Mills, R.D., Pennsylvania.

We do hereby release the Township of Decatur and the Board of Supervisors of Decatur Township, from any and all damages which may be occasioned to our property by the taking over of such road by Decatur Township.

We do each, individually and severally also hereby specifically grant to Decatur Township, Clearfield County, Pennsylvania, any and all rights, ownership or control we may have in the right-of-way for such road as described above and do acknowledge that such road is necessary for public convenience.

This agreement is applicable only to the right of way involving the property mentioned above.


