REPORT OF THE BOARD OF SUPERVISORS OF BRADFORD
TOWNSHIP, CLEARFIELD COUNTY, PENNSYLVANIA

TO THE HONORABLE COURT:

The Board of Supervisors of Bradford Township,
Clearfield County, Pennsylvania, respectfully represents as
follows:

1. That they are the duly elected Supervisors of
Bradford Township, Clearfield County, Pennsylvania.

2. That the roadway vacated is as follows:

(a) Township Road T-614 from the
intersection of Township Roads T-605 and
Township Road T-614 by its various courses
and distances in a northerly direction for a
distance of 620 feet and from the
intersection of Township Roads T-614 and T-
605 by its various courses and distances in a
southerly direction for a distance of 1595
feet.

(b) That attached hereto and made a part hereof and marked Exhibit "C" is a map entitled "Roadway Abandonment Plat" of the "Clearfield Foundation Project" which has been prepared and surveyed by L. Robert Kimball & Associates, Inc. dated April 22, 1992 with the metes and bounds of Township Road T-614 as vacated set forth thereon and the portion of roadway vacated marked in orange.

3. That in the judgment of the Board of Supervisors, it is a benefit to the Township to vacate said portion of the roadway to promote industrial development within the municipality.

4. That as required by Statute, a Notice of the proposed enactment of the Ordinance and of the holding of a Public Meeting in relation thereto, copy of which is attached hereto as Exhibit "A", was given to the following:

ORDINANCE NO. 92-4

AN ORDINANCE OF BRADFORD TOWNSHIP, CLEARFIELD COUNTY VACATING TOWNSHIP ROAD T-614 FROM A POINT 620 FEET NORTH OF TOWNSHIP ROADS T-614 AND T-605 BY ITS VARIOUS COURSES AND DISTANCES IN A SOUTHERLY DIRECTION TO THE INTERSECTION OF TOWNSHIP ROADS T-605 AND T-614 AND FROM A POINT 1595 FEET SOUTH OF THE INTERSECTION OF TOWNSHIP ROADS T-605 AND T-614 BY ITS VARIOUS COURSES AND DISTANCES IN A NORTHERLY DIRECTION TO THE INTERSECTION OF TOWNSHIP ROADS T-614 AND T-605.

WHEREAS, Township Road T-614 is a duly opened Township Road of Bradford Township, Clearfield County which extends in a North-South direction from State Route 1010 in a southerly direction to the intersection with Township Road T-605 and from an intersection with Township Road T-605 in a southerly direction to the intersection with State Route 322; and

WHEREAS, pursuant to Section 1101 of the Second-Class Township Code, 53 P.S. Section 66101, the Township Supervisors of Bradford Township ("Supervisors") are empowered to vacate a township road if, in the judgment of the Supervisors, it is necessary; and

WHEREAS, the Supervisors have held a public meeting as to the merits of this proposed Ordinance on June 16, 1992 pursuant to Section 1102 of the Second-Class Township Code, 53 P.S. Section 66102;

AND WHEREAS, to accomodate a large industrial project, it is necessary, in the judgment of the Supervisors, that parts of Township Road T-614 be vacated and closed which will include 620 feet of Township Road T-614 from a point 620 feet North of the intersection of

Township Roads T-614 and T-605 in a southerly direction to the intersection of Township Roads T-614 and T-605 and from a point 1595 feet South of the intersection of Township Roads T-605 and T-614 in a northerly direction to the intersection of Township Roads T-614 and T-605, as hereinafter ordained.

NOW THEREFORE, the Supervisors hereby ordain the following:

1. That Township Road T-614 is hereby vacated and closed from the intersection of Township Roads T-605 and Township Road T-614 by its various courses and distances in a northerly direction for a distance of 620 feet and from the intersection of Township Roads T-614 and T-605 by its various courses and distances in a southerly direction for a distance of 1595 feet.

2. The the metes and bounds of the parts of Township Road T-614 which are being vacated and closed are set forth on a map entitled "Roadway Abandonment Plat" of the "Clearfield Foundation Project" which has been prepared and surveyed by L. Robert Kimball & Associates, Inc. dated April 22, 1992, and which is on file at the office of the Supervisors at the Bradford Township Building located along State Route 17053, Woodland, Pennsylvania, and which map will be filed in the Prothonotary's Office of the Court of Common Pleas of Clearfield County.

3. That this Ordinance shall become effective on
August 1, 1992.


