REPORT OF BOARD OF SUPERVISORS OF LAWRENCE TOWNSHIP

Report of the Board of Supervisors of Lawrence Township make the following report as to the vacation of Township Road T-600:

1. The Township Supervisors held a public hearing on Monday, July 7, 1994 at 7:00 P.M. at the Lawrence Township building, George Street, Clearfield, Pennsylvania, to consider vacating a portion of Lawrence Township Road T-600. A copy of the notice and copy of the proof of publication are attached hereto as Exhibit "A".
2. Following the public hearing, the Board of Supervisors of Lawrence Township filed a notice to adopt an ordinance vacating a portion of Lawrence Township Road T-600 on July 23, 1994. A copy of said notice and copy of proof of publication are hereto attached as Exhibit "B".
3. On August 2, 1994 the Lawrence Township Supervisors adopted the ordinance vacating a portion of Lawrence Township Road T-600. An executed copy of the Ordinance is hereto attached as Exhibit "C". The draft and survey of the Board of that portion of Township Road T-600 which has been vacated is hereto attached and marked Exhibit "D".
4. This Report is being submitted in accordance with §66102 of the Second Class Township Code of 1933, May 1, P.L. 103, art.

AN ORDINANCE OF LAWRENCE TOWNSHIP, CLEARFIELD COUNTY VACATING A PORTION OF TOWNSHIP ROAD T-600 BEGINNING AT ITS INTERSECTION WITH T-599 AND EXTENDING IN A GENERALLY EASTERLY DIRECTION BY ITS VARIOUS COURSES AND DISTANCES FOR APPROXIMATELY 7/10'S OF A MILE TO THE POINT WHERE IT MEETS THE PAVED PORTION OF T-600, WHICH IS ALSO THE ACCESS ROAD TO THE CLEARFIELD - LAWRENCE TOWNSHIP AIRPORT.

WHEREAS, Township Road T-600 is a duly opened Township Road of Lawrence Township, Clearfield County, which extends from an intersection with Lawrence Township Road T-599 in a generally easterly direction to SR 879; and

WHEREAS, a portion of said Township Road T-600 begins at its intersection with T-599 and extends in a generally easterly direction by its various courses and distances for approximately 7/10's of a mile to the point where it meets the paved portion of T-600, which is also the access road to the Clearfield - Lawrence Township Airport; and

AND WHEREAS, to accommodate the public convenience it is the judgment of the Supervisors, that part of Township Road T-600 beginning at its intersection with T-599 and extending in a generally easterly direction by its various courses and distances

for approximately 7/10's of a mile to the point where it meets the paved portion of T-600, which is also the access road to the Clearfield - Lawrence Township Airport be vacated and closed as hereinafter ordained.

NOW, THEREFORE, the Supervisors hereby ordain the following:

1. That Township Road T-600 is hereby by vacated and closed from the beginning at its intersection with T-599 and extending in a generally easterly direction by its various courses and distances for approximately 7/10's of a mile to the point where it meets the paved portion of T-600, which is also the access road to the Clearfield - Lawrence Township Airport.

2. The survey and location of Township Road T-600 which is hereby vacated is set forth on the Lawrence Township Road Map which is on file at the office of the Supervisors at the Lawrence Township Building located on George Street, Clearfield, Pennsylvania, and which map will be filed in the Prothonotary's Office of the Court of Common Pleas of Clearfield County.

3. That this Ordinance shall become effective August 2, 1994.
