REPORT OF THE BOARD OF SUPERVISORS OF
GULICH TOWNSHIP, CLEARFIELD COUNTY, PENNSYLVANIA

TO THE HONORABLE COURT:

The Board of Supervisors of Gulich Township, Clearfield County, Pennsylvania, respectfully represents as follows:

1. That they are the duly elected Supervisors of Gulich Township, Clearfield County, Pennsylvania.

2. That the roadway and alley vacated are as follows:

(a) All that certain piece or parcel of land situate in the Village of Janesville, Gulich Township, Clearfield County, Pennsylvania, bounded and described as follows:

BEGINNING at a point at the Southwest corner of intersection of Walnut Street and Bridgens Street; thence North fifty-seven (57) degrees forty-four (44) minutes West along the line of land of Dwight E. Close two hundred nineteen and eleven one-hundredths (219.11) feet to a point; thence North five (5) degrees eleven (11) minutes West along Eastern side of the old Railroad to Viola North five (5) degrees eleven (11) minutes West along the Easter side of the old Railroad twenty-nine and thirty-nine one-hundredths (29.39) feet to a point; thence North zero (00) degrees fifty-nine (59) minutes West along the same forty-three and eighty-five one-hundredths (43.85) feet to a point; thence South fifty-seven (57) degrees forty-four (44) minutes East along the line of land of Dwight E. Close two hundred sixty-one and two one-hundredths (261.02) feet to a point; thence South thirty-two (32) degrees sixteen (16) minutes West along the Western side of Walnut Street sixty (60.00) feet to a point and place of beginning, containing 0.322 acres, more or less, and being part of Bridgens Street between Walnut Street and the old Railroad to Viola, as shown on Plot by George A. Cree, Registered Surveyor, 2417 Skyline Drive, Fallentimber, PA 16639.

- (b) All that certain piece or parcel of land situate in the Village of Janesville, Gulich Township, Clearfield County, Pennsylvania, bounded and described as follows:

BEGINNING at a point at the Southeast corner of the intersection of the two Alleys, said point being one hundred eighty (180) feet West of Walnut Street; thence South thirty-two (32) degrees sixteen (16) West along the line of land of Dwight E. Close three hundred nine and sixty-five one-hundredths (309.65) feet to a point; thence North six (6) degrees sixteen (16) minutes West along the East side of the old railroad to Viola twenty-five and sixty-eight one-hundredths (25.68) feet to a point; thence North thirty-two (32) degrees sixteen (16) minutes East along the line of land of Dwight E. Close two hundred eighty-nine and fifty-six one-hundredths (289.56) feet to a point; thence South fifty-seven (57) degrees forty-four (44) minutes East along the South side of the Alley sixteen (16.00) feet to the point and place of beginning, containing 0.11 acres, more or less, and being the Alley running from the old Railroad to Viola, to the other Alley, as shown on Plot by George A. Cree, Registered Surveyor, 2417 Skyline Drive, Fallentimber, PA 16639.

- (c) That attached hereto and made a part hereof and marked Exhibit "A" is a plot prepared by George A. Cree, Registered Surveyor dated August 9, 1995 with the area having been vacating being marked in red.

3. That in the judgement of the Board of Supervisors, it is a benefit to the Township to vacate said roadway and alley, having never been opened by the Municipality and being entirely bounded by the property of a single property owner.

4. That the abutting property owner is Dwight E. Close, who originally requested that the Township vacate said roadway and alley and who was personally served with a copy of the Notice of the proposed enactment of the Ordinance affecting said roadway and alley on June 21, 1996. Copy of said Notice is attached hereto and made a part of this Report designated as Exhibit "B".

5. That pursuant to said Notice and following advertisement is required by law, the Board of Supervisors of Gulich Township did enact an Ordinance No. 7-3-96, copy of which is attached hereto as Exhibit "C" on July 3, 1996.



Ordinance No. 7-3-96

AN ORDINANCE OF THE BOARD OF SUPERVISORS OF
GULICH TOWNSHIP, CLEARFIELD COUNTY,
PENNSYLVANIA, VACATING A PORTION OF THE
ROADWAY KNOWN AS "BRIDGENS STREET" AND AN
ADJOINING ALLEY LOCATED IN THE VILLAGE OF
JANESVILLE, GULICH TOWNSHIP.

The Board of Supervisors of Gulich Township, Clearfield
County, Pennsylvania enacts and ordains as follows:

SECTION IDECLARATION OF PURPOSE

Section 1.01: WHEREAS, Section 11101 of the Second Class Township
Code, (53 P.S. § 66101) permits township supervisors to enact,
ordain, survey, lay out, open, widen, straighten, vacate and relay
all roads within the township; and

Section 1.02: WHEREAS, the property owner adjoining the roadway
and alley to be vacated has petitioned the Township to close and
vacate any claim which the Township may have to said roadway and
alley; and

Section 1.03: WHEREAS, in the judgement of the Board of
Supervisors, it is a benefit to the Township to vacate any claim to
this section of Bridgens Street and the adjoining alley, as same
have never been opened nor maintained by the Township and there
appears to be no benefit to the Township for any future opening.

SECTION IIVACATION

Section 2.01: The Township hereby vacates the section of Bridgens
Street which is bounded and described as follows:

All that certain piece or parcel of land situate in the Village of
Janesville, Gulich Township, Clearfield County, Pennsylvania,
bounded and described as follows:

BEGINNING at a point at the Southwest corner of
intersection of Walnut Street and Bridgens Street; thence

Close two hundred sixty-one and two one-hundredths (261.02) feet to a point; thence South thirty-two (32) degrees sixteen (16) minutes West along the Western side of Walnut Street sixty (60.00) feet to a point and place of beginning, containing 0.322 acres, more or less, and being part of Bridgens Street between Walnut Street and the old Railroad to Viola, as shown on Plot by George A. Cree, Registered Surveyor, 2417 Skyline Drive, Fallentimber, PA 16639.

Section 2.01: The Township hereby vacates the section of the alley which adjoins Bridgens Street which is further bounded and described as follows:

All that certain piece or parcel of land situate in the Village of Janesville, Gulich Township, Clearfield County, Pennsylvania, bounded and described as follows:

BEGINNING at a point at the Southeast corner of the intersection of the two Alleys, said point being one hundred eighty (180) feet West of Walnut Street; thence South thirty-two (32) degrees sixteen (16) West along the line of land of Dwight E. Close three hundred nine and sixty-five one-hundredths (309.65) feet to a point; thence North six (6) degrees sixteen (16) minutes West along the East side of the old railroad to Viola twenty-five and sixty-eight one-hundredths (25.68) feet to a point; thence North thirty-two (32) degrees sixteen (16) minutes East along the line of land of Dwight E. Close two hundred eighty-nine and fifty-six one-hundredths (289.56) feet to a point; thence South fifty-seven (57) degrees forty-four (44) minutes East along the South side of the Alley sixteen (16.00) feet to the point and place of beginning, containing 0.11 acres, more or less, and being the Alley running from the old Railroad to Viola, to the other Alley, as shown on Plot by George A. 


