W I T N E S S E T H :

That for and in consideration of the sum of One and  
no/100 (\$1.00) Dollar, in hand paid, the receipt whereof is  
hereby acknowledged, the said Grantor does hereby grant and  
convey to the said Grantee, its successors and assigns,  
ALL that certain piece or parcel of land located in Bradford  
Township, Clearfield County, Pennsylvania, bounded and described  
as follows:

BEGINNING at a 3/4" rebar (set) at the northeast corner  
of lands of James B. Amon, said rebar being on the  
southern right of way of the Relocated Township T-605,  
said rebar also being the northwest corner of the New  
Township Road T-611 and the parcel herein conveyed and  
running; thence along the southern right of way of the  
relocated Township Road T-605 South 77 Degrees 39  
Minutes 38 Seconds East a distance of 33.49 feet to a  
3/4" rebar (set), said rebar being on the eastern right  
of way of the New Township Road T-611; thence along the  
eastern right of way of the New Township Road T-611 and  
along the western line of lands of Al Hamilton  
Contracting Co., Inc. South 02 Degrees 33 Minutes 37

Seconds West a distance of 530.55 feet to a point; thence still along the eastern right of way of the New Township Road T-611 and along the western line of lands of Ray S. and Louise S. Walker South 06 Degrees 14 Minutes 39 Seconds West a distance of 179.17 feet to a point, said point being on the eastern right of way of the existing Township Road T-611; thence along the existing Township Road T-611 and through the center line of said Road North 81 Degrees 14 Minutes 17 Seconds West a distance of 33.03 feet to a point, said point being on the western right of way of the existing Township Road T-611; thence along the western right of way of the New Township Road T-611 and along the eastern line of lands of Ray S. and Louise S. Walker North 06 Degrees 14 Minutes 39 Seconds East a distance of 176.66 feet to a point; thence still along the Western right of way of the New Township Road T-611 and along the eastern line of lands of Ray S. and Louise S. Walker and lands of James B. Amon North 02 Degrees 33 Minutes 37 Seconds East a distance of 535.17 feet to a 3/4" rebar (set) and place of beginning.

CONTAINING 0.538 as shown on map prepared by Curry and Associates dated May 8, 1992 and revised July 9, 1992. Bearing based on western right of way of Old Township Road T-611 as described on Deed Book 1359 page 486.

The purpose of this Deed is to describe the relocated section of Township Road T-611.

For the purpose of complying with the Act of July 17, 1957, P.L. 984; 52 P.S. Supp. 1551, as amended, of the General Assembly of Pennsylvania, and for no other purpose, there is incorporated herein the following notice:

THIS DOCUMENT MAY NOT SELL, CONVEY, TRANSFER, INCLUDE OR INSURE THE TITLE TO THE COAL AND THE RIGHT OF SUPPORT UNDERNEATH THE SURFACE LAND DESCRIBED OR REFERRED TO HEREIN, AND THE OWNER OR OWNERS OF SUCH COAL MAY HAVE THE COMPLETE LEGAL RIGHT TO REMOVE ALL OF SUCH COAL AND, IN THAT CONNECTION, DAMAGE MAY RESULT TO THE SURFACE OF THE LAND AND ANY HOUSE, BUILDING OR OTHER STRUCTURE ON OR IN SUCH LAND. THE INCLUSION OF THIS NOTICE DOES NOT ENLARGE, RESTRICT OR MODIFY ANY LEGAL RIGHTS OR ESTATES OTHERWISE CREATED, TRANSFERRED, EXCEPTED OR RESERVED BY THIS INSTRUMENT.

AND, the said Grantor will WARRANT SPECIALLY AND FOREVER DEFEND the property hereby conveyed.

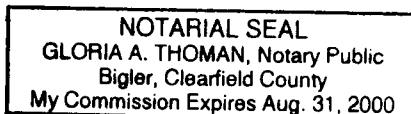

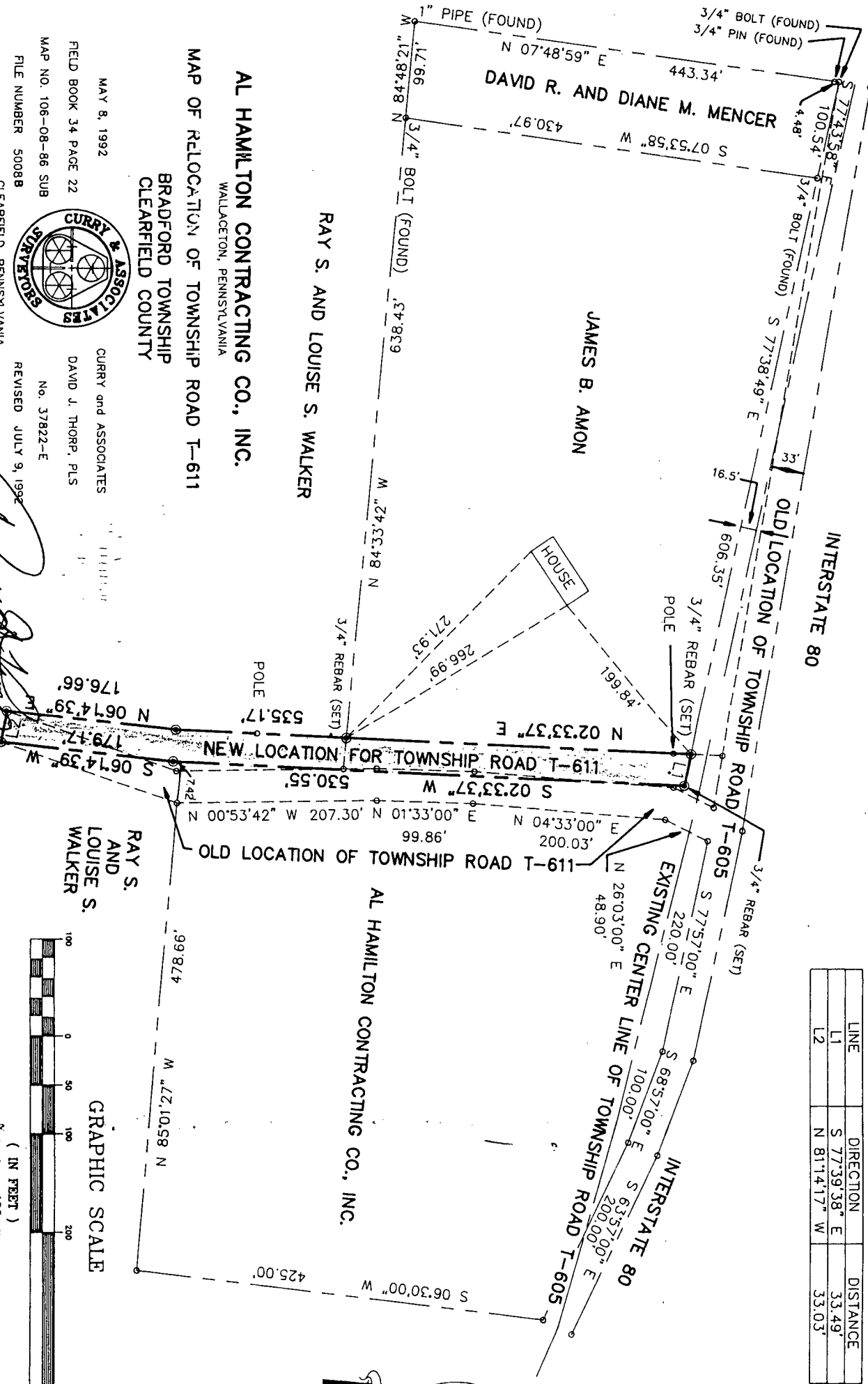

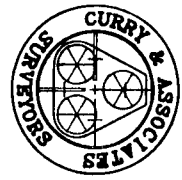

ROAD EASEMENT

1. It is hereby agreed that Ray S. Walker and Louise S. Walker, his wife, both of Bigler, Clearfield County, Pennsylvania, hereinafter called "GRANTORS," in consideration of the sum of \$1.00 and other good and valuable consideration paid by Bradford Township, a municipal corporation incorporated under the laws of Pennsylvania, hereinafter called "GRANTEE," do grant, sell and convey unto the GRANTEE a non-exclusive easement and right-of-way upon and across the following described property of GRANTORS located in Bradford Township, Clearfield County, Pennsylvania, hereinafter called The "Easement Property":

The property is described in the deed recorded in the Office of The Clearfield County Recorder of Deeds at Deed book volume 496, page 485.

2. The easement rights herein granted shall be used only for the purpose of draining water onto and over GRANTORS land via outlets located on Township Road 321 (McDowell Road).

3. The easement rights granted herein to GRANTEE are non-exclusive. GRANTORS reserve and retain the right to convey identical or similar rights and easements to such other persons as GRANTORS may deem proper.


4. The easement rights granted herein to GRANTEE are perpetual, and shall be binding on the heirs, executors, administrators, successors and assigns of the parties hereto.

5. GRANTORS retain, reserve, and shall continue to enjoy the use of the surface of such property for any and all purposes which do not substantially interfere with and prevent the use by GRANTEE of the within Easement.




