WHEREAS, the Department of Transportation and this Municipality have agreed to transfer from state to municipal control the portion of

S. R. 1006 From segment 80 offset 2253
(state route) To segment 170 offset 2501

A distance of 4.9519 miles, in accordance with 75 Pa C.S., Chapter 92 and subject to completion by the Department of the rehabilitative work enumerated on the attached Form M-4226, which the Department and the municipality agree would put the highway in acceptable condition, and

Additional Mileage Information:

LR 17051 from station 182 + 88 to station 445 + 02
A distance of 26,146 feet or 4.9519 miles.

Actual field measured footage: 26,137 (in feet).

WHEREAS, the Department and the municipality have agreed that annual maintenance payments under 67 Pa C.S., Section 9511(g) shall be paid to the municipality, beginning April 1, 2000, the approximate amount of payment will be based on the \$2,500 per lineal mile payable under the provisions of the Department's Transfer Program.

Pursuant to the provisions of 75 Pa. C.S. Chapter 92, TRANSFER OF STATE HIGHWAYS, the portion of the following State Route located in Goshen Township is hereby deleted from the State System.

HEREIN INCLUDED:

SR 1006 (LR 17051) from segment 0080 offset 2253 (station 182+88) to segment 0170 offset 2501 (station 445+02), a distance of 26,137 feet or 4.95 miles.

HEREIN EXCLUDED:

18' bridge at BMS ID NO. 17/1006/0090/0305
43' bridge at BMS ID No. 17/1006/0090/1288

This action is taken with the concurrence of the Township as evidenced in the attached Resolution 98:4.

As of December 31, 1998, the responsibility for maintenance, construction and reconstruction of the portion of highway described above reverts to the Township. This portion of highway will not be placed on the Township's mileage system for Liquid Fuels Tax Reimbursement under Act 655 of 1956, for April 1, 1999; however, beginning on April 1, 2000, annual payments will be made in the amount of \$12,375.00 under 75 Pa. C.S. 9511(g). This amount is based on the \$2500 per lineal mile payable under provisions of the Department's Highway Transfer Program.

The Engineering District 2-0 Highway Turnback Coordinator will provide the Township with copies of the straight-line diagrams, all available right-of-way information, and will be happy to furnish any personal assistance needed.

NOTE: It is important that you provide a copy of this legal transfer of ownership to the Office in the County Courthouse which is responsible for Municipal Road Dockets and that you furnish the Department, through the Engineering District, with proof that the transfer has been recorded in the County Courthouse. The Department will not begin making the annual payments under 75 PA. C.S. 9511(g) unless and until it receives proof that the transfer has been duly recorded in the Courthouse.

The Department of Transportation appreciates your cooperation.

Please be advised that on November 29, 2001, the Pennsylvania Department of Transportation, Bureau of Municipal Services, received the Township's repayment check for State Route 1006 (LR 17051) in the amount of \$291, 753.69 (Check No. 3756 dated October 25, 2001).

Effective November 29, 2001 the Commonwealth resumed jurisdiction over the road and responsibility for its maintenance and repair as part of the state highway system in accordance with the State Highway Law, as amended; the Administrative Code of 1929, as amended; other applicable statutes and the current policies of the Department of Transportation.

Therefore, with the Commonwealth's resumption of jurisdiction over the road, Goshen Township's responsibilities for it shall cease.

This resumption of Commonwealth jurisdiction over the road is in accordance with the provisions of Termination Supplemental No. 020192-A between the Commonwealth and the Township.

The Department of Transportation wants to thank everyone involved for their complete cooperation in resolving this matter.
