  - 18" Concrete pipe needs flushed. Add inlet right side.
3. Segment 40/Offset 0425
  - 18" Concrete pipe needs flushed. Add inlet, right side.
4. Segment 60/Offset 1255
  - Replace existing cross pipe with 35 feet of 48" corrugated metal pipe, add inlet right side, install guiderail both sides.
5. Segment 60/Offset 2061
  - Replace existing cross pipe with 40 to 100 feet of 18" corrugated plastic pipe with smooth liner, add inlet, right side.
6. Segment 60/Offset 2765
  - 18" new corrugated metal pipe is OK. Add inlet, right side.
