1. Segment 10/Offset 0360 - 18" Corrugated Metal Pipe needs flushed.
2. Segment 10/Offset 0584 - 18" Corrugated Metal Pipe needs flushed, add inlet left side.
3. Segment 10/Offset 0655 - 24" Concrete Pipe needs flushed.
4. Segment 10/Offset 1144 - 18" Concrete Pipe needs flushed. Add inlet, left side.
5. Segment 10/Offset 1470 - 18" Concrete Pipe needs flushed.
6. Segment 10/Offset 1768 - 18" Concrete Pipe needs flushed.
7. Segment 10/Offset 2067 - Replace existing cross pipe with 50' of 18" corrugated plastic pipe with smooth liner, add inlet, left side.
