**TOWNSHIP OF SANDY**RESOLUTION NO. 14 - 1999

**WHEREAS**, the TOWNSHIP OF SANDY was offered a certain 50 foot street for a public roadway as part of a Subdivision Plan of Alpha Mining Corporation, with the Plan dated in 1978; and

**WHEREAS**, the Planning Commission of the TOWNSHIP OF SANDY approved the Subdivision Plan in June of 1980 and forwarded a letter to the Supervisors requesting approval of the Plan by the Township; and

**WHEREAS**, the Township Supervisors approved the Plan the 9<sup>th</sup> day of June, 1980 at a regular meeting held that date and the Map was thereafter recorded on July 1, 1980 in File 3/700 in the Recorder's Office of Clearfield County; and

**WHEREAS**, the approval by the TOWNSHIP OF SANDY contained wording to the effect that the approval was not an acceptance necessarily of the 50 foot road shown on the Plan; and

**WHEREAS**, the TOWNSHIP OF SANDY however did physically take control of a portion of the 50 foot road shortly after June of 1980 and has continuously utilized the portion of the said road as a Township road and maintained and treated it as such.

**NOW, THEREFORE, BE IT RESOLVED AND IT IS HEREBY RESOLVED** by the Board of Supervisors of the TOWNSHIP OF SANDY at a regular meeting of the Board held this 7<sup>th</sup> day of July, 1999:

1. That the entire 50 foot road shown on the Subdivision Plan of Alpha Mining Corporation dated the 15th day of March, 1979 be and hereby is formally accepted as a Sandy Township road.

2. That the acceptance be of the entire 50 foot width as shown on the said Plan/map.
