REPORT OF THE BOARD OF SUPERVISORS OF
DECATUR TOWNSHIP, CLEARFIELD COUNTY, PENNSYLVANIA

TO THE HONORABLE COURT:

The Board of Supervisors of Decatur Township, Clearfield County, Pennsylvania,
respectfully represents as follows:

1. That they are the duly elected Supervisors of Decatur Township,
Clearfield County, Pennsylvania.
2. That the roadway vacated is as follows:
 - (a) That portion of T-678, also known as Line Road, beginning at a
point 584 feet from the intersection of T-678 with T-676, also
known as Graham Station Road, and running North approximately
2,795 feet to the Morris Township Line.
 - (b) That attached hereto and made a part hereof and marked Exhibit
"A" is a plot from the Clearfield County Assessment Map with the
area having been vacated being marked in red.
3. That in the judgment of the Board of Supervisors, it is a benefit to the
Township to vacate said roadway; it being entirely bounded by the property of a single
property owner and an alternate route being readily available.

That the abutting property owners are Terry L. and Shirley Siegfried and Cornell Corrections, Inc., who originally requested that the Township vacate said roadway and who were served with a copy of the Notice of the proposed enactment of the Ordinance affecting said roadway on May 28, 1999 and June 3, 1999. Copies of said Notices are attached hereto and made a part of this Report designated as Exhibits "B" and "C". Cornell Corrections, Inc. further waived the ten (10) day Notice of the Public Hearing

5. That the roadway taken is as follows:

- (a) Being a cul-de-sac with a radius of fifty (50') feet located at what is now the end of T-678, also known as Line Road, lying to the Northeast of said existing roadway on the property of Terry L. Siegfried and Shirley Siegfried and Cornell Corrections, Inc., with current Assessment Map Number 112-0-P11-000-00019, adjacent to the property line of said tract and property of John Dean Burns, et al. with current Assessment Map Number 112-0-P11-000-00032. Said cul-de-sac is now part of T-678.
- (b) That attached hereto and made a part hereof and marked Exhibit "A" is a plot from the Clearfield County Assessment Map with the area having been taken being marked in blue.

6. That in the judgment of the Board of Supervisors, it is a benefit to the Township to take said cul-de-sac as it is an improvement to T-678 and the ground for said cul-de-sac is being taken with the agreement of the property owners.

9. That pursuant to said Notices and following advertisement as required by law, the Board of Supervisors of Decatur Township did enact an Ordinance No. 62, copy of which is attached hereto as Exhibit "I" on June 8, 1999.

10. That prior to the enactment of said Ordinance, a hearing was held at the Decatur Township Building, Decatur Township, on June 8, 1999 at 6:00 o'clock p.m., at which time no objections to the proposed vacating of said roadway were raised.

11. That copy of Proof of Publication of the Notice of the meeting and proposed Ordinance is attached hereto as Exhibit "J".

Ordinance No. 62

AN ORDINANCE OF THE BOARD OF SUPERVISORS OF
DECATUR TOWNSHIP, CLEARFIELD COUNTY,
PENNSYLVANIA, VACATING A PORTION OF T-678
KNOWN AS LINE ROAD AND TAKING A CUL-DE-SAC AT
THE END OF THE REMAINING PORTION OF T-678.

The Board of Supervisors of Decatur Township, Clearfield County, Pennsylvania
enacts and ordains as follows:

SECTION I

DECLARATION OF PURPOSE

Section 1.01: WHEREAS the Second Class Township Code, (53 P.S. §67304) permits township supervisors to enact, ordain, survey, lay out, open, widen, straighten, vacate and relay all roads within the township; and

Section 1.02: WHEREAS, in the judgment of the Board of Supervisors, it is a benefit to the Township to vacate a portion of T-678 being entirely bounded by the property of a single owner and an alternate route being readily available, and a benefit to take a cul-de-sac as an improvement to T-678 and being taken with the agreement of the property owners.

SECTION II

VACATION

Section 2.01: The Township hereby vacates a section of T-678, as follows:

That portion of T-678, also known as Line Road, beginning at a point 584 feet from the intersection of T-678 with T-676, also known as Graham Station Road, and running North approximately 2,795 feet to the Morris Township Line.

SECTION III

TAKING

Section 3.01: The Township hereby takes a cul-de-sac which shall hereinafter be known as a part of T-678, also known as Line Road, as follows:

Being a cul-de-sac with a radius of fifty (50') feet located at what is now the end of T 678, also known as Line Road, lying to the Northeast of said existing roadway on the property now or formerly of Terry L. 
Section 4.01: This Ordinance shall become effective five (5) days after the date of the enactment.






Notice is hereby given on June 8, 1999 at 7:00 p.m. at a regular meeting of the Decatur Township Board of Supervisors at the Decatur Township Building, the Decatur Township Board of Supervisors intend to discuss and adopt an Ordinance known as:

AN ORDINANCE OF THE BOARD OF SUPERVISORS OF DECATUR TOWNSHIP, CLEARFIELD COUNTY, PENNSYLVANIA, VACATING A PORTION OF T-678 KNOWN AS LINE ROAD AND TAKING A CUL-DE-SAC AT THE END OF THE REMAINING PORTION OF T-678.

The Board of Supervisors of Decatur Township, Clearfield County, Pennsylvania enacts and ordains as follows:

SECTION I

DECLARATION OF PURPOSE

Section 1:01: WHEREAS the Second Class Township Code, (53 P.S. §67304) permits township supervisors to enact, ordain, survey, lay out, open, widen, straighten, vacate and relay all road within the township; and

Section 1:02: WHEREAS, in the judgment of the Board of Supervisors, it is a benefit to the Township to vacate a portion of T-678 being entirely bounded by the property of a single owner and an alternate route being readily available, and a benefit to take a cul-de-sac as an improvement to T-678 and being taken with the agreement of the property owners.

SECTION II
VACATION

Section 2:01: The Township hereby vacates a section of T-678, as follows: That portion of T-678, also known as Line Road, beginning at a point 584 feet from the intersection of T-678 with T-676, also known as Graham Station Road, and running North approximately 2,795 feet to Morris Township Line.

SECTION III
TAKING

Section 3:01: The Township hereby takes a cul-de-sac which shall hereinafter be known as a part of T-678, also known as Line Road, as follows:

Being a cul-de-sac with a radius of fifty (50') feet located at what is now the end of T-678, also known as Line Road, lying to the Northeast of said existing roadway on the property now or formerly of Terry L. Seigfried and Shirley Seigfried and Cornell Corrections, Inc., with current Assessment Map Number 112-0-P11-000-00019, adjacent to the property line of said tract and property of John Dean Burns, et al. with current Assessment Map Number 112-0-P11-000-00032.

SECTION IV
EFFECTIVE DATE

Section 4:01: This Ordinance shall become effective five (5) days after the date of the enactment.

A public hearing on the proposed vacation and taking shall be held on June 8, 1999 at 6:00 p.m. at the Decatur Township Building.
