JAN 30 2002 WHEREAS, the Clearfield Educational Foundation has

constructed a roadway upon land leading from S.R. 322 to the

WHEREAS, the Lawrence Township Supervisors have named  
the street University Drive, Township Route T969; and

WHEREAS the Clearfield Educational Foundation has  
delivered a Deed of Dedication for said roadway by Deed dated  
October 30, 1997 which has been recorded in the Office of the  
Recorder of Deeds of Clearfield County in Deed and Record Book  
1888, page 187, on November 10, 1997; and

WHEREAS, it is the purpose of the Resolution to comply  
with §67316 of the Second Class Township Code and to accept the  
roadway as a public road of Lawrence Township.

NOW, THEREFORE, BE IT RESOLVED THAT:

1. Lawrence Township does hereby accept the Deed of  
Dedication of the Clearfield Educational Foundation's roadway  
which shall be named University Drive. The roadway is hereafter  
described as follows:



2. That the Secretary is hereby directed to file a certified and attested copy of the Resolution with the Clerk of


the Court of Common Pleas of Clearfield County, whereupon said road shall become a part of the public road system of Lawrence Township.



DEED OF DEDICATION

THIS DEED OF DEDICATION is made this 20th day of October, 1997, between CLEARFIELD EDUCATIONAL FOUNDATION, a non-profit corporation with an office and place of business located at 125 East Market Street, Borough of Clearfield, Clearfield County, Pennsylvania 16830 ("CEF") and LAWRENCE TOWNSHIP, a second class township with its office and principal place of business located at George Street, Clearfield, Pennsylvania 16830 ("the Township").

WHEREAS, CEF has constructed upon the hereinafter described land a roadway leading from S.R. 322 to the termini thereof; and

AND WHEREAS, it is the intention of this Deed to dedicate and convey the right-of-way, together with the roadways constructed thereon to the Township to be used for the purpose of public streets.

NOW, THEREFORE, for and in consideration of the sum of One (\$1.00) Dollar and other good and valuable consideration and intending to be legally bound hereby, the CEF does hereby grant and convey to Lawrence Township the following land upon which a roadway has been constructed for the purpose of public streets leading from the right-of-way of S.R. 322 to the termini of said street, which premises are more particularly bounded and described as follows:

five (35") seconds East, three hundred twenty-nine and sixteen hundredths (329.16) feet to a point; by a curve to the right with a radius of fifty and zero hundredths (50.00) feet, the chord of which is, North seventy-four (74°) degrees fourteen (14') minutes twelve (12") seconds East, ninety-two and fifty-seven hundredths (92.57) feet to a point; by another curve to the right with a radius of fifty and zero hundredths (50.00) feet, the chord of which is, South twenty-nine (29°) degrees forty-seven (47') minutes forty-three (43") seconds West, ninety-two and fifty-seven hundredths (92.57) feet to a point; South fifty-three (53°) degrees eighteen (18') minutes thirty-five (35") seconds West, three hundred thirty and fifty-nine hundredths (330.59) feet to a point; South fifty-three (53°) degrees eleven (11') minutes zero (00") seconds West, thirty-four and eighty-eight hundredths (34.88) feet to a point; by a curve to the left with a radius of seventy-six and zero hundredths (76.00) feet, the chord of which is, South thirty-eight (38°) degrees twenty-four (24') minutes twenty-nine (29") seconds West, thirty-eight and seventy-six hundredths (38.76) feet to a point; South twenty-three (23°) degrees thirty-seven (37') minutes fifty-nine (59") seconds West, four hundred fifteen and six hundredths (415.06) feet to a point; by a curve to the right with a radius of seventy and zero hundredths (70.00) feet, the chord of which is, South sixty-eight (68°) degrees forty (40') minutes forty-four (44") seconds West, ninety-nine and seven hundredths (99.07) feet to a point; North sixty-six (66°) degrees sixteen (16') minutes thirty-one (31") seconds West, two hundred forty-six and forty-nine hundredths (246.49) feet to a point; South twenty-three (23°) degrees forty (40') minutes thirty-three (33") seconds West, seventy and zero hundredths (70.00) feet to a point on the Northern right-of-way line of PA Route 322; thence along said right-of-way line, North sixty-six (66°) degrees sixteen (16') minutes thirty-one (31") seconds West, a distance of one hundred and zero hundredths (100.00) feet to a point; thence along land of Clearfield Education Foundation, North twenty-three (23°) degrees forty (40') minutes thirty-three (33") seconds East, a distance of seventy and zero hundredths (70.00) feet to a point; thence along same, North sixty-six (66°) degrees sixteen (16') minutes thirty-one (31") seconds West, a distance of three hundred sixteen and fifty-six hundredths (316.56) feet to a point, the place of beginning.

Kurtz, Jr., et al. dated November 22, 1996 and recorded in the Office of the Recorder of Deeds of Clearfield County in Deed and Record Book 1810, page 498.

TO HAVE AND TO HOLD the same unto and for the use of the said Grantee herein, its successors and assigns forever, and the said Grantor for and on behalf of its successors and assigns covenant with the Grantee, its successors and assigns, against all lawful claimants, the same and every part thereof to **SPECIALLY WARRANT AND DEFEND.**
