TO THE HONORABLE COURT:

The Board of Supervisors of Bell Township, Clearfield County, Pennsylvania,
respectfully represents as follows:

1. That they are the duly elected Supervisors of Bell Township, Clearfield County, Pennsylvania.
2. That the roadway which was vacated is described as follows:
 - (a) Being in Bell Township, Clearfield County, Pennsylvania being Snyder Road a/k/a T-327 as it runs from Covered Bridge Road a/k/a T-322 along the Susquehanna River to a dead end being a distance of approximately 1.24 miles on the south side of the Susquehanna River.
 - (b) That attached hereto and made a part hereof and marked as Exhibit "A" is a map from Clearfield County Mapping with the area being vacated being part of what is marked in red.
3. That the affected property owners are William Joseph Durbin, Jr., Diane K. Durbin, Rorabaugh Lumber Company, R.J. Cornman Railroad Company/Pennsylvania Lines, Inc., Frank J. Hanchar, Irene Hanchar, H. B. McGee, Trustee of the H.B. McGee Revocable Trust, Theo Miller and Kovalchick Corporation, who were served by mail with a copy of Notice
