**GOSHEN TOWNSHIP ORDINANCE NO. 2013-2**

**AN ORDNANCE OF THE TOWNSHIP OF GOSHEN, CLEARFIELD COUNTY,  
PENNSYLVANIA WHICH: (i) ORDAINS, LAYS OUT AND OPENS  
A PORTION OF AN EXISTING TOWNSHIP ROAD UTILIZED BY THE PUBLIC  
AND OTHERWISE MAINTAINED BY THE TOWNSHIP FOR MORE THAN  
TWENTY-ONE (21) YEARS WHICH IS OTHERWISE KNOWN AS A PORTION OF  
TOWNSHIP ROUTE T-630 (a/k/a T. LEE TAYLOR ROAD); AND  
(ii) VACATES A PORTION OF T. LEE TAYLOR ROAD WHICH HAS  
BEEN ABANDONED AND NOT USED AND/OR MAINTAINED FOR  
IN EXCESS OF FIFTY (50) YEARS**

**WHEREAS**, in 1872, Goshen Township laid out, ordained and opened a public road in the Township of Goshen which became known as T. Lee Taylor Road and which proceedings appear of record in the Office of the Prothonotary of the Court of Common Pleas of Clearfield County, Pa., in Road Docket No. 2, Page 11;

**WHEREAS**, sometime between 1930 and 1960, it is believed that mining operations taking place in the vicinity of the aforementioned laid out and opened T. Lee Taylor Road “stripped out” the location of said road and that upon the conclusion of said mining operations, the roadway was reconstructed at a location different than the location where said road was originally laid out, opened, maintained and utilized;

**WHEREAS**, the current location of T. Lee Taylor Road, a/k/a Township Route T-630, has otherwise been opened, improved, continuously utilized by the public and maintained and repaired by Goshen Township for in excess of twenty-one (21) years and thus constitutes and is hereby declared to be a public township road pursuant to 53 P. S. § 67307, at its current location;

**WHEREAS**, Section 2304 of the Second Class Township Code (53 P. S. § 67304) authorizes Second Class Townships, by Ordinance, to ordain, lay out, open and vacate public roads, including any part thereof;

**WHEREAS**, the Board of Supervisors of the Township of Goshen deems it is in the best interest of the citizens of Goshen Township to: (i) formally ordain, lay out and open Township Route T-630 at its current location since it has been utilized by the public, maintained, repaired and improved by Goshen Township for more than twenty-one (21) years; and (ii) to otherwise vacate that portion of the old T. Lee

Taylor Road which has been abandoned and not otherwise utilized by the public despite having been ordained, laid out and opened pursuant to the proceedings appearing in the Office of the Prothonotary of Clearfield County, Pennsylvania in Road Docket No. 2, Page 11;

WHEREAS, the Board of Supervisors of Goshen Township acknowledge they have met and/or spoken with all adjoining land owners of properties adjoining Township Road T-630 (as it is presently utilized, maintained and improved) and also with those landowners through whose properties old T. Lee Taylor Road traverses, and all have agreed to waive the formality of a view and any right to compensation for damages which Goshen Township may or could owe as a result of ordaining, laying out and opening Township Road T-630 where it is currently located and as a result of vacating that portion of T. Lee Taylor Road which has not been utilized and maintained for in excess of fifty (50) years;

WHEREAS, in accordance with Section 2305 of the Second Class Township Code (53 P. S. § 67305) prior to the enactment of this Ordinance, a hearing was held;

WHEREAS, the owners of real properties adjacent to the existing Township Road T-630 and those through whose property the old and now abandoned T. Lee Taylor Road previously traversed, as depicted on the FINAL MAP OF ROAD LOCATION T-630, dated January 24, 2013, and revised February 14, 2013, prepared by Gary L. Thorp, PLS, which is attached hereto and made a part hereof as Exhibit "A", were given ten (10) days' written notice of the time and place of said hearing;

WHEREAS, pursuant to Section 2311 of the Second Class Township Code (53 P. S. § 67311), any time when the Board of Supervisors of a Second Class Township relocates and/or vacates any part of a public road upon agreement with the property owners affected by said relocation and/or vacation, said relocation and/or vacation may be accomplished without the formality of a view provided a copy of the agreement regarding said relocation and/or vacation, accompanied by a map of said relocated and/or vacated roadway is recorded in the Office of the Recorder of Deeds; and

WHEREAS, all of the adjacent property owners of both: (i) the current location of Township Route T-630 as it currently exists and is located; and (ii) that portion of T. Lee Taylor Road which is no longer in use and has otherwise been abandoned, have agreed with Goshen Township for it to undertake and enact this Ordinance, without the formality of a view and without the payment of any damages.

NOW, THEREFORE, BE IT ENACTED AND ORDAINED BY THE BOARD OF SUPERVISORS OF THE TOWNSHIP OF GOSHEN, CLEARFIELD COUNTY, PENNSYLVANIA, and it is hereby enacted and ordained as follows:

SECTION I - That the portion of Township Road T-630 (a/k/a T. Lee Taylor Road) at the location where the same currently exists, by virtue of it having been utilized by the public and having otherwise been maintained, repaired and improved by Goshen Township for in excess of twenty-one (21) years, the same is hereby recognized and declared to be a public Township Road having a right-of-way of thirty-three (33.0') feet pursuant to 53 P. S. § 67307. Said portion of Township Road T-630 (a/k/a T. Lee Taylor Road) is otherwise more fully described on the attached Exhibit "A" and has a centerline description of the cartway portion of said road as shown and described on Exhibit "B", both of which are attached hereto and made a part hereof. Otherwise, the Board of Supervisors hereby ordain, lay out and open, at said location, a public road and thoroughfare of Goshen Township, Clearfield County, Pennsylvania, to be henceforth known as Township Route T-630.

SECTION II - That the portion of the public road known as T. Lee Taylor Road (which has been abandoned and not utilized by the public for over fifty (50) years), as depicted in the proceedings filed of record in the Office of the Prothonotary of the Court of Common Pleas of Clearfield County, Pennsylvania, to Road Docket No. 2, Page 11, situate in the Township of Goshen, Clearfield County, Pennsylvania, and being more fully depicted on the attached Exhibit "A" with the centerline of said abandoned and non-utilized roadway appearing on Exhibit "C" both of which are attached hereto and made a part hereof, is hereby and shall henceforth be vacated as a public road, street, alley or thoroughfare of Goshen Township, and shall otherwise be closed for public use and traffic in accordance with the terms of the AGREEMENT,

RELEASE AND WAIVER OF DAMAGES PURSUANT TO 53 P. S. § 67311(b), which is attached hereto and incorporated herein by reference as Exhibit "D".

SECTION III - This Ordinance shall become effective thirty (30) days after enactment unless an interested party shall file exceptions to this Ordinance together with a petition for review with the Court of Common Pleas of Clearfield County, Pennsylvania, in accordance with Section 2305(c) of the Second Class Township Code (53 P. S. § 67305(c)), in which event the Ordinance shall become effective only after review and final disposition of the petition in accordance with existing law.

SECTION IV - SEVERABILITY. Should any section, paragraph, clause or phrase of this Ordinance be declared unconstitutional or invalid by a court of competent jurisdiction, the remainder of said Ordinance shall not be affected thereby, and shall remain in full force and effect.

SECTION V - REPEALER. All Ordinances or parts of Ordinances or Resolutions conflicting with the provisions of this Ordinance are hereby repealed to the extent of such conflict.

AGREEMENT, RELEASE AND WAIVER OF DAMAGES  
PURSUANT TO 53 P. S. § 67311(b)

WHEREAS, Goshen Township (hereafter referred to as "Township"), being a Second Class Township organized and existing under the laws of the Commonwealth of Pennsylvania, by virtue of an Ordinance soon to be considered for enactment (Goshen Township Ordinance No. 2013-2) intends to ordain, lay out and open at its current location a Township Road otherwise to be known as Township Route T-630 which has been utilized by the public, and otherwise maintained, repaired and improved by the Township for a continuous period in excess of twenty-one (21) years;

WHEREAS, by said same Ordinance, the Township intends to vacate a portion of the old Township road (otherwise known as "T. Lee Taylor Road") which has become abandoned and has not been utilized by the public for in excess of fifty (50) years;

WHEREAS, the affected real property owners whose properties are either adjacent to the current Township Road T-630 and/or adjacent to the old Township Road (being otherwise known as "T. Lee Taylor Road" as described in Road Docket No. 2, Page 11), and the Township have reached an agreement that it is proper for the Township to open, relocate, lay out and ordain Township Route T-630 at its current physical location and likewise to vacate the old portion of T. Lee Taylor Road which has been abandoned and otherwise not utilized, without the formality of

the appointment of a Board of View and without the awarding and/or payment of any monetary damages to said property owners;

WHEREAS, the Township and the affected Township property owners wish to reduce the agreement to writing.

W I T N E S S E T H:

NOW, THEREFORE, in consideration of the covenants, conditions and provisions contained herein and intending to be legally bound hereby, the parties hereto agree as follows:

1. The undersigned affected property owners hereby agree to the relocation, ordaining, laying out and opening of Township Route T-630 at its current physical location as depicted on the "FINAL MAP OF ROAD LOCATION T-630", dated January 24, 2013, as revised on February 14, 2013, prepared by Gary L. Thorp, PLS, (a true and correct copy of which is attached hereto and made a part hereof as Exhibit "A" with the centerline of the cartway portion of said road appearing on Exhibit "B" which is also attached hereto and made a part hereof), without the need for appointment of a Board of View and without the awarding and/or payment of any monetary damages and/or expenses to the property owners, by the Township.

2. The undersigned affected property owners also hereby agree to the Township vacating that portion of the old Township Road (being otherwise known as "T. Lee Taylor Road") which has become abandoned and has not be utilized by public for in excess of fifty (50) years, which is more specifically depicted on the 'FINAL MAP OF ROAD LOCATION T-630", dated January 24, 2013, as revised February 14, 2013, prepared by Gary L. Thorp, PLS, (a true and correct copy of which is attached hereto and made a part hereof as Exhibit "A", with the centerline of said abandoned and non-utilized road appearing on Exhibit "C" which is also attached hereto and made a part hereof), without the need for appointment of a Board of View and without the awarding and/or payment of any monetary damages and/or expenses to the property owners, by the Township.

3. The property owners, by virtue of their undersigned signatures, hereby agree to release the Township for any claim for damages, expenses and/or any type

of monetary compensation and otherwise agree and waive any and all rights they have to the appointment of a Board of Viewers to assess damages to which they may be entitled to under the Second Class Township Code or any other provision of Pennsylvania law.

4. In exchange for the above, Township will continue to maintain and repair all necessary improvements making up Township Route T-630 at its current location.
5. This Agreement shall be construed under and in accordance with the laws of the Commonwealth of Pennsylvania.
6. Separate signature pages may be signed by each property owner and all the separate signature pages will be attached to and become a part of this Agreement.
7. This Agreement constitutes the sole and only agreement of the parties hereto relative to the herein described subject matter.
