The condition of this obligation is such if the costs of the viewing and expenses of the Court of Quarter Sessions of Clearfield County shall be placed on the petitioners who have petitioned for a public road beginning at a point on the public road leading from Winburne to Kylertown at or near the house of Harry Latz, in said township, and ending at a point on the public road from Munsons to Winburne at or near the residence of August Zellmer, in Cooper township, shall be placed on the petitioners, then this obligation shall be in full force and virtue else to be void.
