And now, this 27 day of July, 1910, the matter of the proposed public bridge between Coulpert Borough and Beccaria Township, having come before the County Commissioners for action, after favorable recommendation by the Grand Jury, and conditional approval by the court; and the Commissioners having, on the 22nd day of July 1910, together with ~~the~~ counsel, made personal investigation of the location to be bridged; and it appearing by the evidences on the ground, as well as by the testimony of persons locally interested, that neither at the initiation of the proceedings, nor at the time of investigation ~~and~~, there was any public highway in Beccaria Township, crossed by a stream, to be bridged; and counsel having advised that such state of facts was fatal to the proceedings in their present form.

Therefore be it resolved, that action upon the aforesaid public bridge be suspended, and that a copy of this resolution be presented to the court in lieu of the estimate referred to in his qualified approval of the bridge.
