BECCARIA AND GULICH TWP.

In re: Change of public roads in Gulich
and Beccaria Townships =

Now. Nov 13th 1911. petition of Boards of
Supervisors of Gulich and Beccaria Town-
ships. for approval of a change of public
roads in Gulich and Beccaria Townships, and
supply thereof by a new public road on East side
of Muddy Run in Gulich Township, presented and
considered; and it appearing that the owners
of lands through which said roads pass have
waived and released all claims for damages, and
the proposed change being for the public interest
and benefit; it is ordered and decreed that
upon the completion by the Berwind White
Coal Mining Company of the proposed new
road on East side of Muddy Run, beginning in
public road 980 feet East from Bridge crossing
Muddy Run, and ending in public road 950
South from intersection of said public road
with a public road from Ittahrille - and
acceptance thereof by the Supervisors of Gulich
Township, the change and vacation of
the roads supplied by the new road
as set forth in the petition. is approved
and the new road as aforesaid ~~is~~ is
approved, and the said new road shall
be taken deemed to be a public road to all intents
and purposes, and the old locations shall be
taken and deemed to be vacated. and the new
road shall thenceforth be kept and maintained
by the proper Township authorities.

To the Honorable Allison C. Smith, President Judge of the
Court of Quarter Session of Clearfield County:

The petition of the Boards of Supervisors of the Townships
of Beccaria and Gulich, in said County, respectfully represents:

That a public road is now open and in use from the village
of Beccaria in Beccaria Township, said County, at residence of Thomas
Turnbull intersecting at said residence with road from Utahville
to Beccaria, and running from said intersection at Turnbull resi-
dence along the West side of Muddy Run to an intersection with
public road leading from Janesville to Utahville; that the said
road lying between the two intersections as aforesaid has become
useless, inconvenient, and burdensome, and the public using said
road can be better accommodated by a road laid out and opened on
the East side of Muddy Run;

That in connection with the same proposed vacation and supply
desired and proposed as aforesaid, a public road in Gulich Township
said County, from its intersection with a public road leading from
Janesville to Beccaria, said intersection being at place and point
known as the Keystone house, to a point *two hundred eighty*
East feet from ~~and~~ bridge carrying said road over Muddy Run, will by
the vacation and new location of the public road as proposed in
the first paragraph of this petition, become useless, inconvenient
and burdensome, ~~and~~

That both of the public roads aforesaid can be changed,
vacated and supplied by a new public road beginning at *two hundred*
eighty feet *East* from the bridge crossing
Muddy Run, being bridge carrying road from Keystone house as afore-
said over Muddy Run, and intersecting the public road leading from
Janesville to Beccaria at a point *Nine Hundred and*
fifty feet ~~from~~ ~~Pennsylvania Railroad~~
intersection of another public road from Utahville with the public

road aforesaid leading from Janesville to Beccaria. Road at intersection
to be seventy feet wide, tapering to thirty feet wide, fifty feet from
intersection.

That the first piece of road proposed to be vacated lies in Beccaria Township; that the second piece of road proposed to be vacated lies in Gulich Township; and the supply for both roads is located in Gulich Township:

That The Berwind White Coal Mining Company has agreed to make and build said supply road at its own expense, in as good average condition as either of the roads proposed to be vacated. ~~Said road to be properly constructed to be not less than 16 feet wide at any point, and to be properly sewered and ditched.~~ That a plan or blue print is hereto annexed and made part of this petition, and said plan shows the locations of the roads, courses and distances, as proposed to be vacated and supplied.

Wherefore the petition of the Supervisors of the Township aforesaid respectfully pray that the Court approve the change of said public roads, and the supply thereof by a new road, as indicated on the plan hereto annexed, so that the new location for said roads shall be taken to be a public road to all intents and purposes and the old locations shall be taken and be deemed to be vacated. Your petitioners further representing that the owners of all lands affected by the proposed changes have waived and released all claims for damages by reason thereof, as appears by annexed release.
