At a Court of Quarter Sessions of the Peace of the County of Clearfield, held at Clearfield, Pa., in and for said County, on the 13 day of December in the year of our Lord one thousand nine hundred nineteen,


Judge of the same Court: Upon the petition of sundry inhabitants of the Township of Larrence in said County, setting forth that,

and therefore, praying the Court to appoint proper persons to view and lay out the road between the points mentioned, whereupon the Court upon due consideration had of the premises, do order and appoint from and among the County Board of Viewers A. G. Kramer, Esq., Harry Reese and A. L. Edwards

who have been duly appointed by the Court and filed their oaths of office and are duly qualified to perform the duties of their appointment with impartiality and according to the best of their judgment, are to view the ground proposed for the said road, and if they view the same, and a majority of the actual viewers agree that there is occasion for such road; they shall proceed to lay out the same, as agreeable to the desire of the petitioner as may be, having respect to the best ground for a road and the shortest distance, in such a manner as to do the least injury to private property; and shall make report thereof, stating particularly whether they judge the same necessary for a public or private road, together with a plot or draft thereof, and the courses and distances and references to the improvements through which the same may pass; (and wherever practicable, the viewers shall lay out the said road at an elevation not exceeding five degrees, except at the crossing of ravines and streams, when by moderate filling and bridging the declination of the road may be preserved within that limit,) to the next Court of Quarter Sessions to be held for the said County.

And if the viewers aforesaid shall decide in favor of locating a public road, they shall obtain from the persons through whose lands the said road shall pass, releases from any damages that may arise to them on opening the same; but if the owner or owners of such land refuse to release their claim to damages, the said viewers shall assess the same, taking into view the advantages as well as disadvantages arising from said location, and make report of such assessments; which report they shall in like manner transmit to the next Court or Quarter Sessions, with the draft or plot aforesaid. In which said reports they shall state that they have been sworn or affirmed according to law, and that due and legal notice was given of the time when, and place where, they should meet, to view and lay out said road, and the time and place of hearing.

RETURN OF VIEWERS.

To the Honorable the Judge of the Court of Quarter Sessions of the Peace for the County of Clearfield:

We, the undersigned viewers, duly appointed by your Honorable Court by the foregoing order, from and among the County Board of Viewers who have been duly appointed by your Honorable Court and have filed their oaths of office in the Court of Common Pleas of Clearfield County, beg leave to report as follows:

That notice of the time of view ~~and of the territory~~ was duly served according to law upon the Commissioners of Clearfield County and the Board of Supervisors of the Township of Lawrence and that three notices thereof were posted along the route of the proposed road, that the said view would be held on the 11th, day of January ----, A. D. 1916, ~~at the meeting house in the Township of Lawrence, Clearfield County, Pennsylvania~~ That

The viewers appointed by the said order viewed the ground proposed for the above mentioned road, and that there were present at the view John M Urey Attorney for the petitioners, Lanz Snyder one of the owners of the property through whose land said road is located and Ed Cowen one of the Supervisors of Lawrence Township ~~and the parties in interest. The hearing was held in the Arbitration Room in the Court House at the corner of Main and Broad Streets in the Township of Lawrence, Clearfield County, Pennsylvania~~

There being no question raised as to the necessity of said road laid out or objection filed as to the location of said road or the vacating of said roads herein recommended to be vacated or demand on the viewers for a hearing the public hearing was dispensed with and After the view ~~at the hearing~~ above mentioned, the undersigned ~~the majority of the~~ viewers, do agree that there is occasion for a road as desired by the petitioner, and that the same is necessary for a public road: And having had respect to the shortest distance and the best ground for such road we have laid out in such manner as shall do the least injury to private property, and as far as practicable agreeably to the desire of the petitioner, and do return for public use the following described road, to-wit: Beginning at a point in the public road leading from the end of Leavy Avenue to Litz's

Bridge seven hundred and fifty eight and four tenth (758.4) feet from dividing line between the Borough of Clearfield and Lawrence Township in said Township; Thence running south fifty one degrees and thirty seconds; east three hundred and twenty seven and five tenth (327.5) feet to the centre of the brick road leading from the end of Ogden Avenue to Litz's bridge in Lawrence Township at a point near where the present Township road hereby vacated, leading from the Brick road known as Ogden Avenue to the Township road hereby vacated known as Leavy Avenue connects with the said brick or State road.





Viewers cannot interfere with the damages assessed by the original viewers, except so far as the location may be changed by the reviewers.


N. B.—If the viewers believe the parties are not entitled to damages, taking into consideration the advantages as well as the disadvantages of the road, they will report to that effect.
