TO THE HONORABLE SINGLETON BELL, PRESIDENT JUDGE OF THE
COURT OF QUARTER SESSIONS OF CLEARFIELD COUNTY:

The petition of the undersigned, inhabitants

In the case of the granting of said road, then this obligation to be null and void otherwise to be and remain in full force and virtue.
