SEALED with our seals and dated the *31st* day of *June*, A. D.
1916.

WHEREAS a petition has been presented to the Court of Quarter
Sessions of Clearfield County at September Sessions 1916 by citi-
zens of Boggs Township for the appointment of viewers to view a
road at a point of the Lawrence Township line at the Dimeling Sta-
tion of the New York Central Railroad to a point where the said
public road intersects or connects with a private road leading
from Ross Lambert's farm, according to the prayer of the petition-
ers this day filed and submitted herewith.

NOW THE ~~COND~~ITION OF THIS OBLIGATION IS SUCH, that if the above
named obligors, their heirs, executors or administrators or any of
them shall in the event that the Court shall order the costs of said
proceedings to review said road above described in Boggs Township,
shall be paid by the petitioners; that the said obligors herein named
