Road in Knox. Twp. :

To the Court of Quarter Sessions of Clearfield County:-

The petition of the undersigned Supervisors of Knox Township, in the said County of Clearfield, respectfully represents:-

That a public road was long since laid out and opened leading from Olanta to Boardman and usually known as the " Olanta and Boardman" road.

That your petitioners deem it advisable to change that part of said road under their supervision passing through the said

Township of Knox, beginning at a point on said road, to-wit:-
*Four hundred feet from where the road intersects with
road leading to Potts Run, in front of the Maple Store
Co's building, as per the Blue Print hereto
attached*

and ending at a point on said road, to-wit:- *about one hundred
and fifty feet beyond Little Potts Run in the direction
of Old Johnsville, as per the Blueprint hereto
attached* which will materially improve the route of said road through said Township.

That the Maple Run Coal Company, a corporation, owns the land on which the proposed change of the route of said road is laid, and the said Maple Run Coal Company, as evidenced by its endorsement hereon, has agreed with your petitioners to release all claims for damages on account of the proposed change in the route of said road and the laying out and opening of the same on its land for public use as of the width of the said road as or-

iginally laid out, and also to pay the costs incident to the making of said change in the route of said road. A map or draft of the said proposed change in connection with the facts herein set forth, as required by the Act of May 5th, 1911, P.L. 123, is hereto attached and made a part of this petition.

Your petitioners therefore pray your Honorable Court to approve said change in the route of said road and thereupon order, adjudge and decree that the new location thus approved shall be taken and deemed to be the public road to all intents and purposes and that the old location between the points of the new location as herein set forth shall be taken and deemed to be vacated.

And they will ever pray, etc.
