Supply of road on Boggs Twp

Versus

IN THE COURT OF QUARTER SESSIONS OF CLEARFIELD COUNTY, PA.  
TO THE HONORABLE THE PRESIDENT JUDGE OF THE SAID COURT:-

The petition of  
the undersigned citizens and residents of the township of Boggs  
in said County of Clearfield respectfully represents:-

That the road leading from the Erie Pike to the Laurel Run  
School House and there connecting with road leading from Wallacet-  
ton to Blue Ball known as the Laurel Run Road is located at  
Laurel Run end of said road a distance of about a quarter of a  
mile from connection with State Highway Route No. 57 as now  
located; that a petition is about to be presented to your  
Honorable Court for the vacation of the Laurel Run Road between  
Blue Ball and Wallacetton from the Warren farm to the Joseph  
Smeal barn in the Village of Blue Ball; said road paralleling  
the State Highway aforesaid and being supplied thereby; that by  
the vacation of said route there will be no connection between  
the road leading from the Erie Pike to what is known as the  
Laurel Run School House with State Highway Route No. 57 and  
in order to make said connection your petitioners pray that a  
public road may be located, viewed and opened leading from the  
point at which the Erie Pike to Laurel Run road intersects the  
Wallacetton to Blue Ball road known as the Laurel Run road to a  
point on State Highway Route No. 57 about six hundred feet to the  
west of the residence of Mrs. Ed Kephart in the Township of  
Boggs, a distance of about one fourth of a mile.
