

At a Court of Quarter Sessions of the Peace of the County of Clearfield, held at Clearfield, Pa., in and for said County, on the 16th day of December in the year of our Lord one thousand nine hundred twenty four

Judge of the same Court: Upon the petition of sundry inhabitants of the Township of Penn in said County, setting forth that that there is a public necessity for a public road leading from a point in a public road leading from Gearhart's to the river, at a point in the line of lands of G. M. Passmore, and the Crescent Fire Brick Company; thence to a point in the public road leading northerly toward Curwensville at the barn of Claude Freeman

and therefore, praying the Court to appoint proper persons to view and lay out the road between the points mentioned, whereupon the Court upon due consideration had of the premises, do order and appoint from and among the County Board of Viewers A. G. Kramer, Esq., Ed. Billotte, and J. S. Michaels

who have been duly appointed by the Court and filed their oaths of office and are duly qualified to perform the duties of their appointment with impartiality and according to the best of their judgement, are to view the ground proposed for the said road, and if they view the same, and a majority of the actual viewers agree that there is occasion for such road they shall proceed to lay out the same, as agreeable to the desire of the petitioner as may be, having respect to the best ground for a road and the shortest distance, in such a manner as to do the least injury to private property; and shall make report thereof, stating particularly whether they judge the same necessary for a public or private road, together with a plot or draft thereof, and the courses and distances and references to the improvements through which the same may pass; (and wherever practicable, the viewers shall lay out the said road at an elevation not exceeding five degrees, except at the crossing of ravines and streams, when by moderate filling and bridging the declination of the road may be preserved within that limit,) to the next Court of Quarter Sessions to be held for the said County.

And if the viewers aforesaid shall decide in favor of locating a public road, they shall obtain from the persons through whose lands the said road shall pass, releases from any damages that may arise to them on opening the same; but if the owner or owners of such land refuse to release their claim to damages, the said viewers shall assess the same, taking into view the advantages as well as disadvantages arising from said location, and make report of such assessments; which report they shall in like manner transmit to the next Court of Quarter Sessions, with the draft or plot aforesaid. In which said reports they shall state that they have been sworn or affirmed according to law, and that due and legal notice was given of the time when, and place where, they should meet, to view and lay out said road, and the time and place of hearing

We, the undersigned viewers, duly appointed by your Honorable Court by the foregoing order from and among the County Board of Viewers who have been duly appointed by your Honorable Court and have filed their oaths of office in the Court of Common Pleas of Clearfield County, be leave to report as follows:

That notice of the time of view and of the hearing day was duly served according to law upon the Commissioners of Clearfield County and the Board of Supervisors of the Township of

Penn, and that Three notices thereof were posted along the route of the proposed road, that the said view would be held on the 13th day of January.

Passmore, Joseph Hague and Claud Freeman in favor of the road, and William Helper one of the Supervisors of the Township of Penn in the County of Clearfield and State of Pennsylvania:

After the view and hearing above mentioned, the undersigned, ~~the undersigned~~ viewers, do agree that there is an occasion for a road as desired by the petitioner, and that the same is necessary for a public road: And having had respect to the shortest distance and the best ground for such road we have laid out in such manner as shall do the least injury to private property, and as far as practicable agreeably to the desire of the petitioner, and do return for public use the following described road, to wit Beginning at the end of a public road leading to Curwensville and the Lumber City road near the residence of G. M. Passmore in Penn Township Clearfield County and State of Pennsylvania: Thence over land of the said G. M. Passmore the following courses and distances, to wit: North, fifty eight (58) degrees; East, one hundred and forty three, feet: Thence North four, (4) degrees, East, two hundred (200) feet. Thence North, nineteen (19) degrees; West two hundred (200) feet, Thence North forty (40) degrees, thirty (30) minutes, west two hundred (200) feet, Thence North, forty eight (48) degrees, thirty (30) minutes, West four hundred (400) feet: Thence North fifty five (55) degrees, West four hundred (400) feet: Thence North fifty seven (57) degrees, West four hundred (400) feet. Thence North forty one (41) degrees, fifteen (15) seconds. West two hundred and forty five (245) feet to the property line of Joseph Hague.

To view a road for public use in a township of Penn Clearfield County Penna.

NOTE.—In case of a private road, the release must be executed in favor of the petitioner for said road.

Also, viewers will carefully note the number of days employed and set the amount out at the foot of their return.

Reviewers cannot interfere with the damages assessed by the original viewers, except so far as the location may be changed by the reviewers.

N. B.—If the viewers believe the parties are not entitled to damages, taking into consideration the advantages as well as the disadvantages of the road, they will report to that effect.
