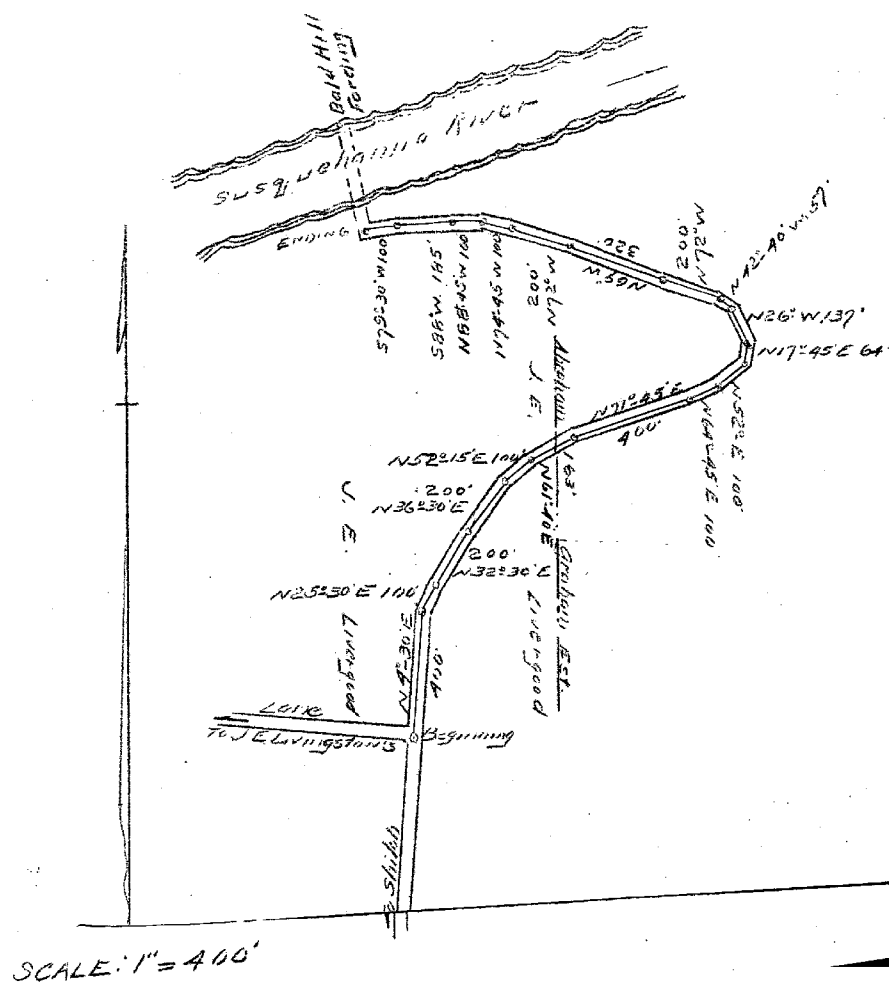

From the J.E.Livergood Lane it runs some 400 feet through cleared fields of J.E.Livergood; these fields and the site of the road have been under cultivation apparently for many years, so that we found it difficult to locate the real location of the road and this was done only by following a slight depression in the surface of the land. The remaining part of the road was more clearly traceable and runs through wood land, down steep hill to the Susquehanna River: this portion of the road is grown over with briars and bushes and has manifestly been unused for a long period of years and having been thus abandoned as a used highway, your Viewers are of one mind that the Road should be legally vacated for the protection of the Bradford Township taxpayers and citizens

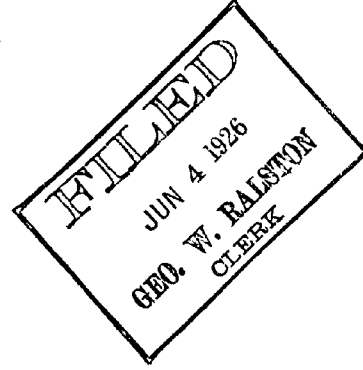
