PETITION.

To the Honorable A.R. Chase, President Judge of said Court.

The petition of Frank E. Wise and the County National Bank of Clearfield, Pennsylvania, guardian of Merle Wise, respectfully represents:-

(1). That the petitioners are the owners of a certain tract of land in Pike Township, Clearfield County, Pennsylvania, bounded and described as follows:-

Beginning at a post on the bank of the West Branch of the Susquehanna River; thence extending along the lands of Henry Hile N. $51\frac{1}{2}^{\circ}$ W. two hundred forty-two (242) perches to a post; thence along lands formerly of Robert Ross N. 39° E. eighty (80) perches to a post; thence along lands formerly of William Irvin S. 51° E. one hundred seventy-eight (178) perches to a post on the bank of the West Branch of the Susquehanna River; thence by said River its several courses and distances to a post and place of beginning. Containing one hundred (100) acres, twenty-eight (28) perches.

Excepting out of same twenty (20) Acres conveyed to Henry Hile and forty (40) acres conveyed to J.E. Clark.

Also, all that other tract in the same Township, beginning at a hemlock on West Branch of the Susquehanna River; thence N. 51° W. one hundred eighty (180) perches to a post on line of land formerly of Robert Ross; thence S. 39° W. eighteen (18) perches by said land to a post; thence S. 51° E. one hundred seventy-eight (178) perches by land of William M. Price to a post on the bank of the River; thence down the River its several courses and distances almost eighteen (18) perches to the place of beginning. Containing twenty (20) acres, twenty-two (22) perches.

Being the same premises which were conveyed to James M. Wise by Fred J. Dyer et ux. by deed dated January 13, 1904, recorded in Clearfield County in Deed Book 144 page 18, and which upon the death of said James M. Wise descended by inheritance to his two sons, petitioners herein.

(2). That the State Highway Commissioner of the State of Pennsylvania has undertaken and proceeded with the construction of an improved State Highway between the Borough of Curwensville and the Borough of Lumber City, running through the aforesaid land of the petitioners in Pike Township.

(3). That petitioners have sustained damages by reason of the construction of said road, the course of which has been considerably changed and upon which a change of width and existing lines and locations has been occasioned, and that the construction of said portion of State Highway has been completed or is approaching completion.

(4). That your petitioners have been damaged by the taking of a substantial quantity of ground amounting to one and one-half ($1\frac{1}{2}$) acres or more, by the destruction of fruit trees, by making certain parts of their farm inaccessible without the building of crossings over the ditches along said road, by the diverting of a large flow of water, making necessary the drainage thereof, and in various other particulars.

(5). That your petitioners have been unable to agree with the County Commissioners of Clearfield County on the amount of damages to be paid to your petitioners for the land appropriated and other injuries resulting to your petitioners.

YOUR PETITIONERS THEREFORE PRAY your Honorable Court to appoint viewers to appear upon the premises and to view and assess the damages and injury for which your petitioners are entitled to receive compensation by reason of the appropriation

of their land and the other injuries incidental to the reconstruction and relocation of said State Highway.

~~by moderate filling and bridging the declination of the road may be preserved within that~~

That notice of the time of view and of the hearing day was duly served according to law upon the Commissioners of Clearfield County ~~and the Board of Supervisors of the Township of~~ ~~_____ and that _____ notices thereof were posted along the route of the~~ ~~proposed road,~~ that the said view would be held on the First day of December A. D. 1927, and the hearing to be held in the Arbitration Room, at the Court House, in Clearfield, Pa., on the Second day of December, 1927, at (9) o'clock A.M. That ~~The~~ viewers appointed by the said order viewed the ground ~~proposed for the above mentioned road,~~ and that there were present at the view That there were present at the the claimants Frank E. Wise and Merle Wise the claimants with their Attorney W. Wallace Smith Esq. and H. B. Powell representing the County National Bank Guardian for Merle Wise under age and two apple trees, and parties in interest. That the hearing was held in the Arbitration Room, in the Court House, at Clearfield, Pa., on the Second day of December A. D. 1927, when the following appearances were noted: Frank E. Wise and Merle Wise the claimants with H. B. Powell representing the County National Bank Guardian for Merle Wise who being under age, with their Attorney W. Wallace Smith Esq. and the County Commissioners with their Attorney Frank Smith Esq representing A. M. Liveright.

~~After the view and hearing above mentioned, the undersigned, the majority of the said viewers, do agree that there is _____ occasion for a road as desired by the petitioner, and that the same is _____ necessary for a _____ road. And having had respect to the shortest distance and the best ground for such road we have laid out in such manner as shall do the least injury to private property, and as far as practicable agreeably to the desire of the petitioner, and do return for _____ use the following described road, to wit Beginning~~

That the petitioners Frank E. Wise and Merle Wise sons of James M. Wise deceased who by inheritance by the death of their father the said James M. Wise became the owner of two certain adjoining tracts of land situate in Pike Township Clearfield County State of Pennsylvania, the one containing forty (40) acres and the other twenty (20) acres a total of sixty (60) acres; Through which said tracts of land of the said claimants to wit Frank E. Wise and Merle Wise the State Highway Commissioner in 1927 in the construction of the State Highway from the Borough of Lumber City to the Borough of Curwensville through Pike Township County and State aforesaid passes through the land of the said claimants 1388 feet in length and on an average including the bern and drain at the upper side of the road and the bern, drain and fill at the south of eastern side of the road averages forty three (43) feet in width which takes one and one half of the claimants land for which the viewers assess the claimants at the rate for the land taken at one hundred (\$100.00) an acre or for the acre and a half of land taken One hundred and fifty (\$150.00 dollars.

For the cost of the erection or construction of a culvert or bridge across or over the drain along the upper side of the road to enable the claimants to get from the State road into their fields on the upper side of the road or from the fields onto the road the sum of twenty five (\$25.00) dollars.

The value of the eight apple trees destroyed by the construction of the road through the claimant's orchard to viewers fix the

value per tree at the price fixed by the claimant and the witnesses
at ten dollars a tree or for the eight trees destroyed at (\$80.00)

For the value of the land destroyed and the inconvenience
by the ditch or drain from the highway down past the side of the
house one hundred and fifty seven feet in length nine (9) feet
in width at the upper end by about three feet at the lower end by
all of three feet in depth at the upper end all of one foot at the
lower end in depth the viewers assess the damages at one hundred
and seventy five (\$175.00) dollars

Therefore making the total damages assessed at \$430.00

and that a plan or draft of said road showing courses and distances and the properties affected
is hereto attached and made a part hereof, said road being at an elevation not exceeding five
degrees, excepting

when it was not practical to preserve it within that limit.

The undersigned further report that they endeavored to procure from all the owners of
the land over which the said road passes releases in writing of all claims to damages that may
