The petition of Charles A. Johnson, Charles Ardary and Morton W. Peters, Supervisors of the Township of Cooper respectfully sets forth that Charles A. Johnson, Charles Ardary, and Morton W. Peters, are the duly qualified Supervisors of the Township of Cooper.

That a Pennsylvania State Highway Route No. 219 was laid out by the Sproul Act of 1911, which said State Highway extends from Clearfield to Bellefonte, and passes, inter alia, from the Village of Munson in Morris Township, to Cooper Township, through the Village of Kylertown; and thence in a general Northerly direction to the line of Centre County and Clearfield County.

That in the Spring of 1926, the Department of Highways of the Commonwealth of Pennsylvania relocated portions of the same, abandoned the portions of the old State Highway not included within the lines of the relocation.

That the various portions of the original State Highway Route No. 219, which were abandoned, have been useless, inconvenient and burdensome, for the reason that the new and improved State Highway Route No. 219, as relocated, furnishes a sufficient and adequate road.

The petitioners pray the Court that the following portions of said Road (leading from the Cooper-Morris Township line, Northerly to the Centre-Clearfield County line) be vacated:-

(1) Beginning at Station 437, plus 25, (Sprout Highway Station,) and ending at Station 480, plus 77, (Sprout Highway Station,) EXCEPTING, that piece of said road between Dicks Store, and ending at the Sandcroft and Boyd McBath line. The amount of road to be vacated being approximately 3900 feet.

(2) Approximately 1573 feet beginning at Station 436, plus 12, Sprout Highway Station, and ending at Station 451, plus 85, Sprout Highway Station.

(3) Approximately 1350 feet, beginning at Station 553, plus 25, Sprout Highway Station, and ending at Station 566, plus 40, Sprout Highway Station.

(4) Beginning where said State Highway Route No. 219, (Sprout location) intersects with the Township road leading to Karthaus, which intersection is North of Station 730, approximately 400 feet, and extends from said intersection to Station 804, plus 20, intersecting with the new macadam re-located state highway, approximately 8,000 feet.

That your petitioners pray that a portion of State Highway Route No. 219, Sprout Act, as abandoned by the State, be vacated and supplied as follows:-

That there be vacated all of said road (except where same be intersected with the new macadam relocated State Highway) for a distance of approximately 3806 feet, beginning

at Sproul Station 574, plus 40, and ending at Sproul Station 612, plus 46, and that said piece of road be supplied by the laying out of a new road for a distance of approximately 600 feet, which new road shall begin at the intersection of the Township Road leading to Sylvan Grove from the abandoned State Highway (near Station 590 Sproul Act) and extending on the same line as the Sylvan Grove line in an Easterly direction to the new macadam relocated State Highway Route No. 219.

Approximately 1573 feet beginning at Station 436, plus 12, Sproul Highway Station, and ending at Station 451, plus 55, Sproul Highway Station.

Approximately 1350 feet beginning at Station 553, plus 25, Sproul Highway Station, and ending at station 566, plus 40, sproul highway station.

Beginning where said state highway Route No. 219, (Sproul location) intersects with the township road leading to Karthaus, which intersection is north of station 730, approximately 400 feet, and extends from said intersection to station 804, plus 20, intersecting with the new macadam relocated state highway approximately 8,000 feet.
