PETITION.

To the Honorable A.R. Chase, President Judge of said Court.

The petition of Charles A. Johnson, Morton Peters and Fred Edlund, Supervisors of Cooper Township, Clearfield County, Pennsylvania, respectfully represents:-

That your petitioners are the legally constituted Supervisors having authority over roads in the Township of Cooper, County of Clearfield and State of Pennsylvania.

That your petitioners deem it advisable to alter a part of a public road in Cooper Township aforesaid leading from the present Township road to Philipsburg at the turn at the Southeast corner of the Nebo Lutheran Church Cemetery, thence in a North-easterly direction to the Township road running to Grassflat South of the land of Morton Peters, said proposed new location to replace, by a road approximately four hundred fifty (450) feet, two other pieces of said road as now existing leading at right angles from the Township road to Philipsburg at the starting place of the proposed road approximately three hundred twenty (320) feet, and then again at right angles along the Grassflat road approximately three hundred (300) feet to the junction of the proposed new road with the road to Grassflat.

That said change in road will improve the road conditions by eliminating two right angled turns and by improving the conditions as to grade, and by substituting a shorter course for two courses aggregating a longer distance.

That the only property owner affected is Herbert Johnson who has agreed to release damages upon payment of the sum of sixteen (\$16.00) Dollars; that his agreement to that effect is attached hereto.

That no inconvenience will result by reason of the vacation of the portions of Township road to be vacated; that the only considerable use of said portions will be for the Cemetery on the Lutheran Church plot, and said roads need not be kept and maintained at public expense.

That the cost of making the change or alteration aforesaid will not exceed the sum of Three hundred (\$300.00) Dollars.

* That a blueprint showing the proposed changed is hereto attached and made a part hereof.

YOUR PETITIONERS THEREFORE PRAY the Court for approval of the change of location of the road aforesaid, in accordance with the Act of May 5, 1911, P.L. 123.
