At a Court of Quarter Sessions of the Peace of the County of Clearfield, held at Clearfield town, in and for said county, on the 22 day of March A. D. 1864 before the Judges of the said Court upon the petition of sundry inhabitants of the township of Osceola in the said county, setting forth that they labor under great inconvenience for the want of a road or highway to lead from Adam

Hepharts to Osceola.

and therefore praying the Court to appoint proper persons to view and lay out the same according to law. **Whereupon** the Court, upon due consideration had of the premises, do order and appoint

John L. Cuttler, John Shaver and Wm Hughes

who, after being respectively sworn or affirmed to perform the duties of their appointment with impartiality and fidelity, are to view the ground proposed for said road, and if any two of them agree that there is occasion for such road, they shall proceed to lay out the same, as agreeable to the desire of the petitioners as may be, having respect for the best ground for a road, and the shortest distance, in such manner as to do the least injury to private property; and shall make report thereof, stating particularly whether they judge the same necessary for a public or private road, together with a plot or draft thereof, and the courses and distances, and reference to the improvements through which it may pass, to the next Court of Quarter Sessions to be held for the said county. In which report they shall state that they have been sworn or affirmed according to law.

To the Honorable the Judges of the Court of Quarter Sessions of the Peace in and for the County of Essex.

The undersigned Reviewers appointed by your Honorable Court by the order hereto annexed Respectfully report that on the 13th day of August 1864. they went upon the ground and viewed the proposed alterations, and proceeded to Review said road, as follows.

Commencing at a post in the public square in Cecelo. thence North 62° West, sixty seven perches to a Post, North 2° West at 19 per Philipburg & Mount Pleasant Road in all 22 perches inside Millars fields, thence North 9° West One hundred perches, through Millars fields, thence North $2\frac{1}{4}^{\circ}$ West 30 perches to Old Road, thence by old road, north 14° West fifty two perches by old road, North 14° West twenty three perches, by old road, North $2\frac{1}{4}^{\circ}$ W. thirty perches by old road, North 43° West seventeen perches, by old road, North 65° West sixty perches, by old road, North 49° West forty perches, North 29° West seventy perches in S. Kephart's fields thence across fields North thirty one and one half degrees West through fields at fifty two perches to a Locust, thence North twenty three degrees West at nineteen perches line fence of Stephen & George Kephart, at eighty eight perches line fence of George Kephart & Walter Morgan at One hundred and fourteen perches to old road, and by old road same course, in all Two hundred and twenty three perches to township road leading from John Goff house to Philipburg, in all Two miles & One hundred and forty six perches, and they recommended the new part of said road to be confirmed and the part vacated to be vacated by the Court, and they also state that the viewers, John Shaw, Mr. Hughes & John L. Guttie, were all upon the ground having been severally sworn to perform the duties of viewers according to law.

And we respectfully recommend the alterations as made by this review to be confirmed by the Court & we assess for damages to Stephen Kephart the sum of Thirty dollars, to George Kephart Fifteen dollars & to Walter Morgan the sum of ten dollars.
