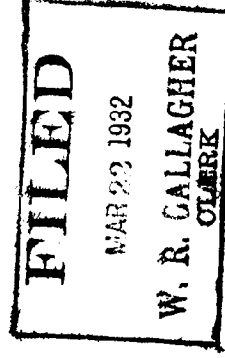

in and for said County, on the 22nd day of March in the year of our Lord, one
thousand nine hundred and thirty two

By the Honorable ~~Singleton~~ **A.R. CHASE** Supervisors
President Judge of the said Court: Upon the petition of sundry
inhabitants of the Township of **Girard**, in the County aforesaid setting forth that

a road beginning at the Surveyor Run Spur of the N Y C. RR at or near
the village of Surveyor and from thence passing through the lands of
Surveyor Run Lumber Company for a distance of approximately two miles
to the Bald Hill fording; has long been an established road in said township
That said portion of township road has become useless, inconvenient and
burdensome

and, therefore, praying the Court to appoint proper persons to view and vacate said road between the
points mentioned, whereupon the said Court, upon due consideration had of the premises, do order and ap-
point from and among the County Board of Viewers **EARL G. BOOSE ESQ, Harry Reese**

and H. P. Dowler who have been duly appointed by the said Court on the
County Board of Viewers, and filed their oaths of office in the office of the Court of Common Pleas of the
County aforesaid, as required by law and are, therefore, duly qualified to perform the duties of their appoint-
ment, with impartiality and according to the best of their judgment; are to view the said road, and after
having viewed the same, if they, or a majority of them, do agree that there is no necessity for said road, they
shall proceed to vacate the same as agreeably to the desire of the petitioners as may be, and make report
thereof to the next Court of Quarter Sessions to be held in and for said County, stating particularly whether
there is any necessity for said road, or whether the same should be vacated; and the reason why, together
with a plot, or draft, thereof showing the courses and distances with reference to the improvements through
which said road passes.

And in case the viewers aforesaid shall decide in favor of vacating said road, they shall obtain from
the persons through whose lands the said road passes, or otherwise affected, or damaged, by the vacating
of said road, releases from whatever damage they may sustain by the vacation of said road; and in case the
owners of such lands, or persons affected, thereby refuse to release their claim to damages, the said Viewers
shall assess the same, taking into consideration the advantages, as well as the disadvantages, arising from
the vacation of said road; and make report of such assessment; which report they shall in like manner trans-
mit to the next Court of Quarter Sessions, with the draft, or plot, aforesaid. In which said reports they
shall state that they have been sworn, or affirmed, according to law, and that due and legal notice was given
of the time when and the place where they would meet, to view said road and the time and place of hearing.

RETURN OF VIEWERS.

TO THE HONORABLE THE JUDGE OF QUARTER SESSIONS OF THE PEACE, IN AND FOR THE
COUNTY OF CLEARFIELD, PA.

We, the undersigned Viewers, duly appointed by your Honorable Court by the foregoing order, from and among the County Board of Viewers who have been duly appointed by your Honorable Court and have filed their oaths of office in the Court of Common Pleas of Clearfield County, beg leave to report as follows:

That notice of the time of the view and of the hearing day was duly served according to law upon the Commissioners of Clearfield County, and the Board of Supervisors of the Township of Girard, and that three notices thereof were posted along the route of the said road to be vacated, that the said view would be held on the 8th day of April, A. D. 1932, and that the public hearing, as required by the Act of Assembly, and the Rules of Court, would be held in the Arbitration Room in the Court House, in Clearfield, Pa., on the 12th day of April, A. D., 1932, at ten o'clock A. M., and that said Viewers, appointed by the said order, viewed the road desired to be vacated, and that there were present at the view Messrs. Paul Smith and Isaac Condon, the Supervisors of Girard Township. No one appeared to oppose the vacation. Because of inability of the viewers to meet for the view on the day and at the hour designated in the notices, an adjournment of the view was had until Monday, the 11th day of April, 1932, at ten o'clock A. M., at which time the view was held. Notice of the postponement was duly noted on the public notices.

parties interested, either in favor of or against vacating said road. And that the aforesaid hearing was held in the Arbitration Room in the Court House, in Clearfield, Pa., on the 12th day of April, A. D. 1932, when the parties interested in the said road were in attendance: There attended the hearing Messrs Paul Smith and Isaac Condon, the Supervisors of Girard Township. No one appeared to oppose the vacation.

And that after the view and hearing above mentioned, the undersigned Viewers do agree that said road has, become useless, inconvenient and burdensome and is not used generally by the traveling public at the present time and apparently has not been so used for a long time, and the Viewers do therefore recommend the vacation of so much of said road as begins at a point immediately south of the spur of the New York Central Railroad, near the village of Surveyor, in said Girard Township, and ends at the Bald Hill Fording of the Susquehanna River.

and that a plan, or draft, of said road to be vacated showing the courses and distances, and over whose property the said road passes, is hereto attached and made a part hereof.

The undersigned Viewers further report that they endeavored to procure from all parties affected by the vacation of said road, or over whose properties said road passes, or in any way damaged by the vacation of said road, a release in writing of all claims to damages that may arise from the vacation thereof, and that they procured such release from:

And that the following persons having, in the opinion of the Viewers, been damaged by the vacation of said road, and having refused to release the damages to which they may be respectively entitled to by reason of the vacation and closing up of the said road, we, the undersigned Viewers, after having considered the advantages to be derived to them, do assess them damages and make report thereof, as follows:

It appearing to the viewers that no one will sustain any damage by reason of the vacation of said public road and no one having appeared at either the view or the public hearing to demand any damage, the Viewers have therefore awarded no damage to any one, resulting from said vacation.

Also, viewers will carefully note the number of days employed and set the amount out at the foot of their return.

Reviewers cannot interfere with the damages assessed by the original viewers, except so far as the location may be changed by the reviewers.

N. B.—If the viewers believe the parties are not entitled to damages, taking into consideration the advantages as well as the disadvantages of the road, they will report to that effect.

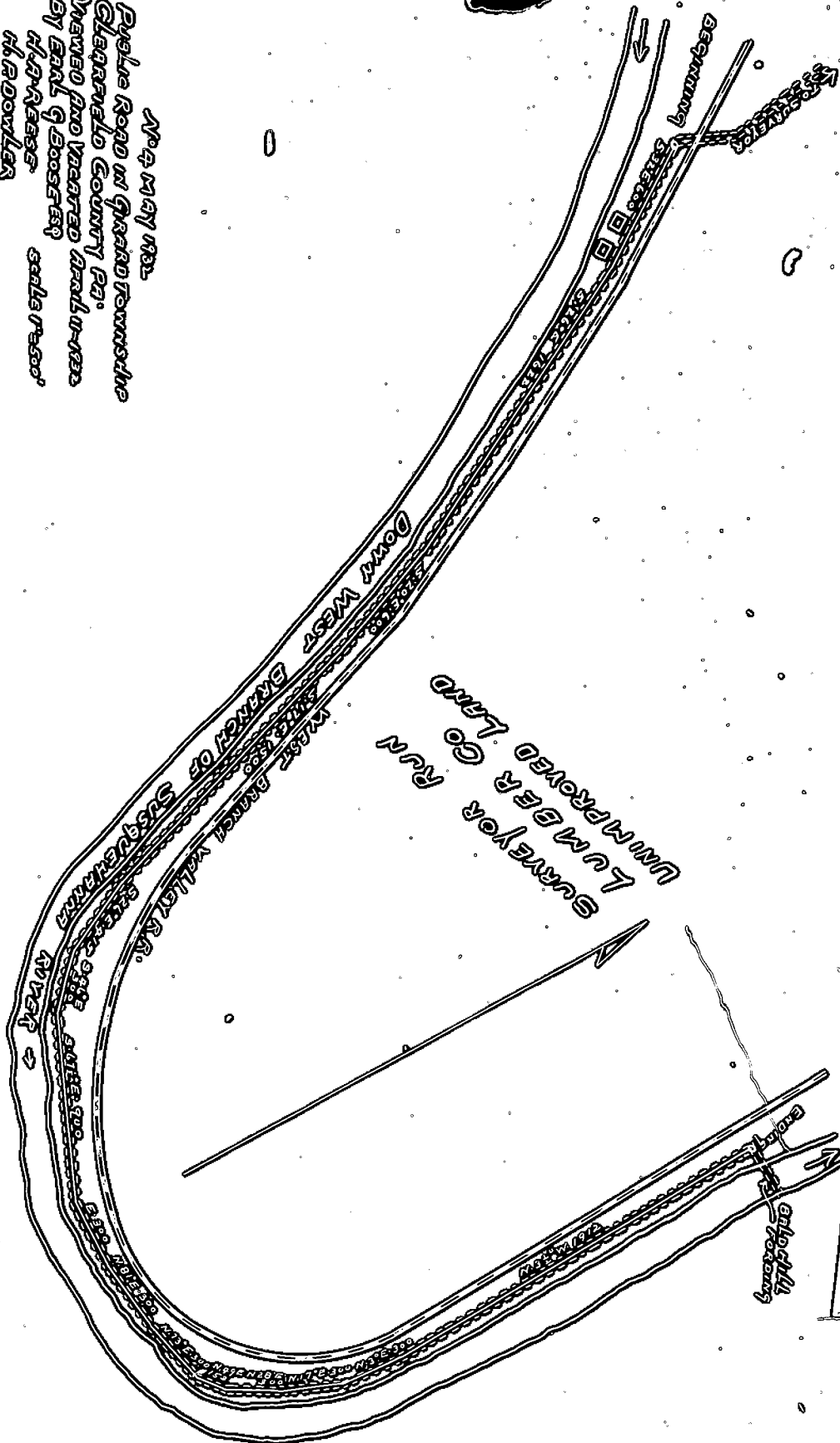

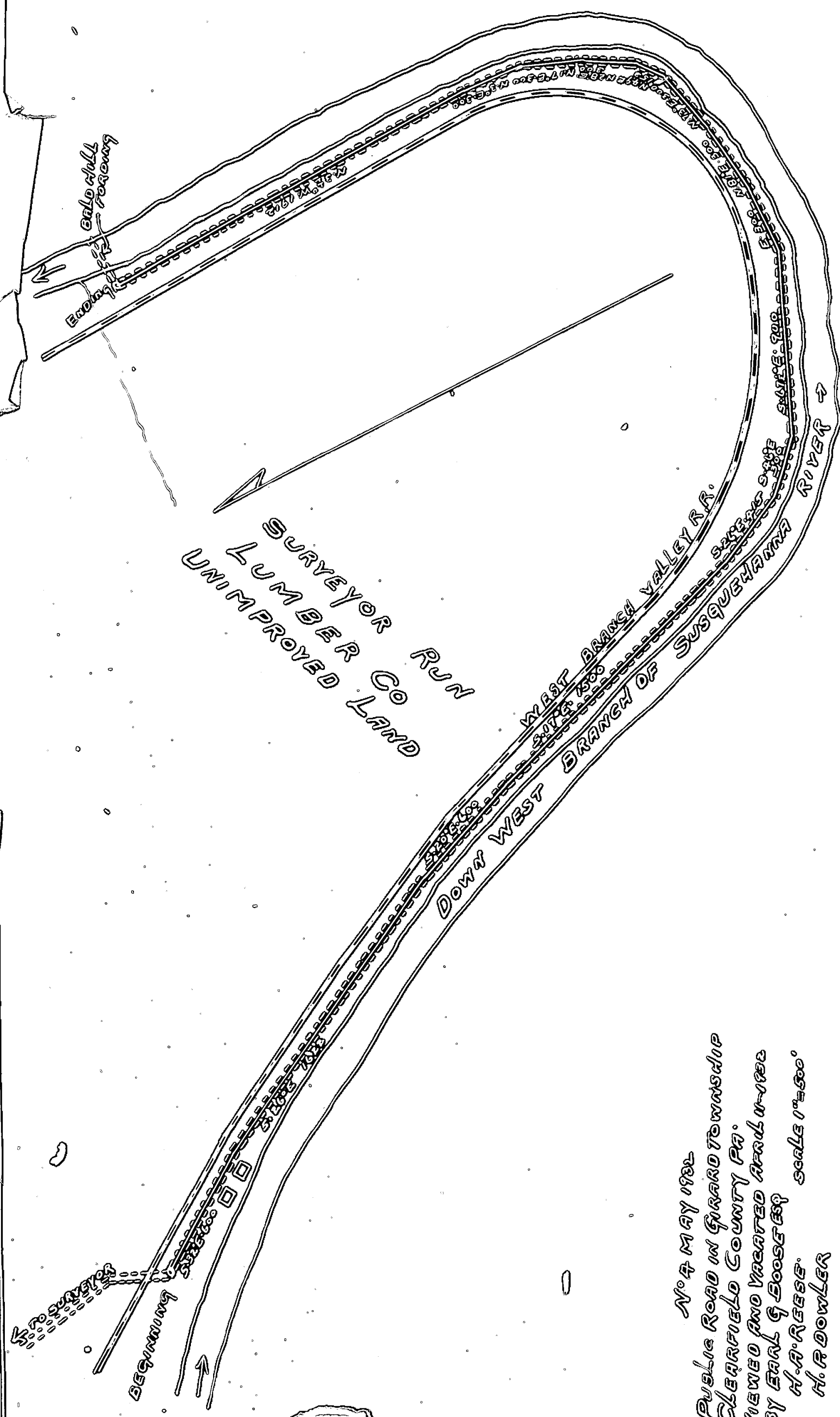
