TO THE HONORABLE W. WALLACE SMITH, PRESIDENT JUDGE OF SAID COURT:

The petition of the Board of Supervisors of Knox Township, Road District respectfully represents:

(1). That your petitioners constitute the Supervisors of the Road District of Knox Township.

(2). At the present time a certain section of road in said Township is being ~~approved~~ under a PWA project and the labor in connection with said improvement is being furnished without cost to the Township. The material used in said improvement is being paid out of Parkinson funds.

(3). The section of road being improved is known and numbered as Route 443 and connects with Route 17038 at the one end and 17036 at the other end.

(4). There exists on said Route No. 443, which is being improved, two sharp and dangerous curves in the neighborhood of the properties of Custer Snyder, John Rea and Park Rea, which curves and dangers may be eliminated at little or no expense to the Road District and by the elimination of said curves the length of the road will be substantially shortened.

(5). The first change will reduce the length of the road from 1350 feet to 1000 feet and will eliminate two dangerous curves.

and will also establish a better grade. The second change will reduce the length of the road from 1100 feet to 800 feet and will likewise eliminate two dangerous curves and establish a better grade.

(6). The property owners affected by the proposed change or alteration have agreed to said change and alteration.

(7). The costs and expenses of said change and alteration including damages to said Township shall not exceed \$500.00.

(8). A map of said road showing the present location of the road and the proposed changes is attached hereto.

(9). Your petitioners deem it advisable to make said change and alteration.

WHEREFORE, your petitioners pray your Honorable Court to approve said change and alteration and that said road as changed and altered shall be taken to be the public road, and the old location vacated.


