

To the Honorable W. Wallace Smith, President Judge of said Court:

The petition of the undersigned residents and citizens of the Townships of Greenwood and Ferguson, Clearfield County and State of Pennsylvania, respectfully represent:

That they labor under great inconvenience by reason of curves and hills in the public road in said Townships which is hereinafter described and which they desire vacated and another laid out instead thereof.

They therefore pray your Honorable Court that that part of the public road, known on the system of Township roads as No. 324 in the Township of Greenwood, Clearfield County, and also the Township of Ferguson, Clearfield County, leading from the Village of Kerrmoor to Bells Landing, be vacated as to that part beginning at a point near Watts Cemetery and ending at a point near the David Barratt Farm and that the vacated portion be supplied by the laying out of a new road between said points in order to eliminate hills and curves existing in the public road.

They therefore pray your Honorable Court to appoint viewers.
