AGREEMENT BETWEEN CLEARFIELD CO.

COMMISSIONERS AND

ROBINSON CLAY PRODUCT CO

Versus

NOTICE

The County Commissioners of Clearfield County, Pennsylvania, have entered into an agreement with The Robison Clay Products Company as to the amount of damages to be paid to The Robison Clay Products Company for damage resulting from the change in width, lines and location of a new portion of State Highway Route 57 section 3, at a point near the Leno-rd Crossing of the Pennsylvania Railroad in Lawrence Township, Clearfield County, Pennsylvania. An agreement was filed in the office of the prothonotary of Clearfield County on the 29th day of June, 1937, and any taxpayer of Clearfield County may file exceptions thereto on or before the 12th day of July, 1937; if exceptions to said agreement are filed, the proceedings will be presented to the Court of Quarter Sessions of Clearfield County, Pennsylvania, in the No. 1 Court Room of the Court House at Clearfield, Pa., at ten o'clock A. M. on the 19th day of July, 1937, when and where any taxpayer may appear and be heard together with his witnesses.

AGREEMENT

BETWEEN J. C. GATEHOUSE, T. R. WEIMER and WILLARD V. CARR, County Commissioners of Clearfield County, Pennsylvania, hereinafter sometimes referred to as County Commissioners, parties of the first par, and THE ROBINSON CLAY PRODUCT COMPANY, hereinafter sometimes referred to as Clay Company, party of the second part.

WHEREAS, Route No. 57 is a State Highway on the plan of the State Highways of the Commonwealth of Pennsylvania; and section 3 thereof is situate in Clearfield County, and

WHEREAS, under a statutory right conferred upon him, the Secretary of Highways of the Commonwealth of Pennsylvania, has undertaken the reconstruction and improvement of said State Highway, and said reconstruction and improvement involved a change in width, of existing lines and of location, and

WHEREAS, the Secretary of Highways so notified the County Commissioners in writing of the contemplated change in such existing width, lines and location, and

WHEREAS, the said County Commissioners agreed in writing to such change in width, lines and location, and

WHEREAS, such change in width, lines and location required the removal and relocation of a certain bucket line tower, the property of Clay Company, from its original location to a point approximately forty-eight feet distant therefrom; it appearing that a pillar of the said bucket line tower, in its original position, was located within the new right of way line and immediately above the proposed location of the pavement, and

WHEREAS, the removal and relocation of said bucket line tower was undertaken by Clay Company, at the request of County Commissioners, and

WHEREAS, the actual cost incurred by Clay Company for materials and labor in removing and relocating the said bucket line tower was Six Hundred Seventy-two and 55/100 (\$672.55) Dollars, as appears by an itemized statement thereof, marked Exhibit "A", annexed hereto, and made a part hereof, and

WHEREAS, County Commissioners believe the said expense to have been necessarily incurred in the removal and relocation of the said bucket line tower.

Now, therefore, this agreement:

WITNESSETH:

(1). In consideration of the premises and of the promises hereinafter set forth on the part of Clay Company, the County Commissioners agree to pay to Clay Company the sum of Six Hundred Seventy-two and 55/100 (\$672.55) Dollars, as damages.

(2). Clay Company agrees to accept said sum of Six Hundred Seventy-two and 55/100 (\$672.55) Dollars in full settlement of its claim against Clearfield County and/or County Commissioners of Clearfield County, for damages arising by reason of the change in width, lines and location of Route No. 57 of the State Highway of the Commonwealth of Pennsylvania, where it crosses the land of Clay Company, and by reason of the removal and relocation of its bucket line tower, said land and bucket line tower being located near the Leonard crossing of the Pennsylvania Railroad in Lawrence Township, Clearfield County, Pennsylvania.

(3). It is mutually understood and agreed that this agreement shall be filed by the County Commissioners in the office of the Prothonotary of Clearfield County; that if no exceptions are filed thereto within ten (10) days after notice given by publication, as required by law, the County Commissioners will pay over to Clay Company, the said sum of Six Hundred Seventy-two and 55/100 (\$672.55) Dollars.

(4). It is further mutually understood and agreed that if exceptions to this agreement are filed within ten days after such notice, the proceeding shall be presented to the Court of Quarter Sessions of Clearfield County for its approval, that the Court shall fix a time for hearing the matter, at which time the parties hereto and any taxpayer interested therein and their witnesses, shall be heard, and the Court shall either approve or disapprove the agreement as it deems proper; if the Court disapproves the agreement and indicates a sum which it would approve if the County Commissioners and Clay Company agree thereon, said sum shall be acceptable by County Commissioners and Clay Company, and it is covenanted by and between the parties hereto that said sum shall take the place of the aforesaid sum of Six Hundred Seventy-two and 55/100 (\$672.55) Dollars; Provided, however, that if the Court disapproves the agreement and fails to indicate a sum which it would approve, then and in such case, this agreement shall be null and void, and Clay Company shall, if it so desires, proceed to present its petition to the Court of Quarter Sessions for the appointment of viewers to ascertain and assess damages in the manner provided by law.

IN WITNESS WHEREOF, the County Commissioners of Clearfield County have hereunto affixed their signatures, duly attested by the Commissioners' Clerk, and The Robinson Clay Product Company, has caused these presents to be executed by its proper officers, and its corporate seal, duly attested, to be hereunto affixed, the 10<sup>th</sup> day of January 1937.
