RESOLUTION

At a regular meeting of the Board of Supervisors of the Township of Union, Clearfield County, Pennsylvania, held on the 11th day of January, 1937, at which the following members were present:

Cecil Bailey

William J. B. Smith

Curtis Harris

The following resolution was adopted on the affirmative vote of all three Supervisors present:-

WHEREAS, On April 10, 1828, Act No. 127 of the 1828 Session of the Assembly, the Snowshoe and Packersville Pike was incorporated.

AND WHEREAS, after being used as a public road for many years, a part of said Pike in Union Township by appropriate proceedings was abandoned as a public road and by order of Court, December Sessions, 1930, the report of the viewers vacating said portion of the Pike in Union Township was confirmed absolutely,

7 AND WHEREAS, Act of Assembly No. 301, which was approved on July 12, 1935, amends the original Rural Route Act No. 203 of June 22, 1931, P. L. 594, provides for the establishment as a State Highway of the following described road:

"Route 17083 - beginning at a point at the end of Route 862 thence in an easterly direction through Union Township to the Union-Pine Township line beginning again at a point at the end of Route 862 thence in an easterly direction through Lawrence Township to the intersection of Route 17041 in Clearfield County a distance of about 2.2 miles."

AND WHEREAS, that portion of the above described route which lies within Union Township, and which is indicated in yellow on the blue print attached to the certified copy of this resolution to be filed in the Court of Quarter Sessions of Clearfield County, cannot be adopted as a part of the State Highway System by virtue of the aforementioned Act No. 301 for the reason that the section of the road involved is now a private instead of a township road.

AND WHEREAS, it is important and necessary in order that there may be an improved road from Union Township over the mountain to Clearfield that this section known as part of the Snowshoe and Packersville Pike be accepted as a public highway.

NOW, THEREFORE, BE IT RESOLVED, that the Board of Supervisors of the Township of Union, accept that portion of the road known as the Snowshoe and Packersville Pike lying in Union Township and indicated in yellow on the blue print attached to the certified copy of this resolution to be filed in the Court of Quarter Sessions of Clearfield County, as a public highway, and be it further resolved that the consent of the Court to this acceptance be acquired and that this resolution be entered upon the minute book and a certified and attested copy thereof be filed with the Court of Quarter Sessions of Clearfield County as provided by Section 47 of the Act of Assembly the 18th day of July, 1935, P. L. 1299.
